ORDER:

In the Government order second read above, orders were issued for restructuring of administrative set up of School Education Department at the field level i.e., Chief Educational Officer (CEO), District Educational Officer (DEO), District Elementary Educational Officer (DEEO), Inspector of Anglo Indian School (IAS), Inspector of Matriculation Schools (IMS) and Assistant Elementary Educational Officer (AEEO) and delegation of the disciplinary as well as administrative powers to field level officers to ensure effective monitoring of schools and quality of education.

2. Accordingly, the Director of School Education has forwarded proposals for amending the Special Rules for Tamil Nadu Elementary Educational Subordinate Service.

3. The Government have examined the proposal of Director of School Education and proposed to issue amendment to the Special Rules for Tamil Nadu Elementary Educational Subordinate Service and issue orders accordingly.

4. The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Articles 309 of the Constitution of India, the Governor of Tamilnadu hereby makes the following

amendments to the Special Rules for the Tamil Nadu Elementary Educational Subordinate Service (Section 48A in volume-III of the Tamil Nadu Services Manual, 2016)

5. The amendments hereby made shall be deemed to have come into force on 18th May 2018.

AMENDMENTS

In the said Special Rules,

- (1) "for the expression 'Assistant Elementary Educational Officer' wherever it occurs, the expression "Block Educational Officer" shall be substituted;
- (2) "for rule 3, the following rule shall be substituted, namely:-

3. Appointing authority:-

*The Chief Educational Officer shall be the appointing authority for the post of Block Educational Officer.
The District Educational Officer of the concerned Educational district shall be the appointing authority for all the remaining classes and categories specified in these rules".*

- (3) in rule 10, for sub-rules (a) and (b), the following sub-rules shall be substituted, namely:-

"(a) Transfer and postings of all classes in the service within the Revenue district shall be made by the Chief Educational Officer concerned. Inter Revenue District Transfer and Postings of all officers in the service shall be made by the Joint Director concerned.

(b) Transfer and postings of all classes in the service within the Educational District shall be made by the District Educational Officer concerned."
