ORDER:-

1. In the Government Order first read above, Special Rules were framed for the posts under the Tamil Nadu School Educational Subordinate Service.

2. In the Government Order second read above, orders were issued for restructuring of administrative set up at the field level and delegation of the disciplinary as well as administrative powers to field level officers to ensure effective monitoring of schools and quality of education.

3. Accordingly, the Director of School Education has forwarded proposals for amending the Special Rules for Tamil Nadu School Educational Subordinate Service.

4. The Government have examined the proposal of Director of School Education and proposed to issue amendments to the special rules for the Tamil Nadu School Educational Subordinate Service.

5. Accordingly, the following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu School Educational Subordinate Service. (Section 48 in Volume III of the Tamil Nadu Services Manual).

2. The amendments hereby made shall be deemed to have come into force on 18th May, 2018.

AMENDMENTS

In the said Special Rules,

1) for rule 5, the following rule shall be substituted, namely:-

"5. Appointing authority,- The appointing authority for all classes shall be the Chief Educational Officer"

2) in rule 16, for sub-rule (a) and (b) the following sub-rules shall be substituted, namely:-

a) (i) Transfer and postings of the personnel in all classes of the service within the revenue districts shall be made by the Chief Educational Officer of the concerned revenue districts

(ii) Transfer and postings of the personnel in all classes of the service within the educational districts shall be made by the District Educational Officer of the concerned educational districts.

(b) Inter Revenue District Transfer and postings of all Officers in the Service shall be made by the Joint Director of School Education (Personnel).
