**Orders:-**

In the Government Order first read above, Special Rule were framed for the posts under the Tamil Nadu Higher Secondary Educational Service.

2. In the Government Order second read above orders were issued for restructuring of administrative set up of School Education Department at the field level i.e. Chief Educational Officer (CEO), District Educational Officer (DEO), District Elementary Educational Officer (DEEO), Inspector of Anglo Indian School(IAS), Inspector of Matriculation Schools (IMS) and Assistant Elementary Educational Officer (AEEO) and delegation of the disciplinary as well as administrative powers to field level officers to ensure effective monitoring of schools and quality of education.

3. Accordingly the Director of School Education has forwarded proposal for amending the Special Rules for Tamil Nadu Higher Secondary Educational Service Rules.

4. The Government have examined the proposal of Director of School Education and proposed to issue amendment to the Special Rules for Tamil Nadu Higher Secondary Educational Service and issue orders accordingly.

5. The following Notification will be published in the Tamil Nadu Government Gazette:-

**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Higher Secondary Educational Service (Section 37 in Volume II of the Tamil Nadu Services Manual).

2. The amendments hereby made shall be deemed to have come into force on the 18<sup>th</sup> May, 2018.

**AMENDMENTS**

In the said Special Rules,

- (1) In rule 3, in the TABLE, for the expression "Joint Director of School Education (Higher Secondary)" in Column (2) against the entries Class II and III, in Column (1) thereof the expression "Chief Educational Officer" shall be substituted.
- (2) For Rule 9, the following Rule shall be substituted, namely:-
  - " 9. (i) Inter Revenue District transfer and postings of all Officers in the Service shall be made by the Joint Director of School Education (Higher Secondary).
  - (ii) Transfer and postings of all Officers in the Service shall be made by the Chief Educational Officers within the Revenue District.
  - (iii) Transfer and postings of all Officers in the Service shall be made by the District Educational Officers within the Educational Districts."
