ORDER:

In the Government order second read above, orders were issued for restructuring of administrative set up of School Education Department at the field level i.e. Chief Educational Officer (CEO), District Educational Officer (DEO), District Elementary Educational Officer (DEEO), Inspector of Anglo Indian School(IAS), Inspector of Matriculation Schools (IMS) and Assistant Elementary Education Officer (AEEOs) and delegation of the disciplinary as well as administrative powers to field level officers to ensure effective monitoring of schools and quality of education.

2. Accordingly the Director of School Education has forwarded proposals for amending the Special Rules for Tamil Nadu School Educational Service.

3. The Government have examined the proposal of Director of School Education and proposed to issue amendments to the Tamil Nadu School Educational Service and issue orders accordingly.

4. The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu School Educational Service (Section 8-A in volume-II of the Tamil Nadu Services Manual, 2016)

2. The amendments hereby made shall be deemed to have come into force on the 18th May, 2018.

AMENDMENTS

In the said Special Rules,

- 1) the expressions "Inspectress of Girls Schools, Inspector of Anglo-Indian Schools wherever it occurs, it shall be deleted.
- 2) In rule 2A, for the expression "Director of School Education", the expression "Chief Educational Officer" shall be substituted.
- 3) In rule 8C, for the expression "in classes IV, V and VI", the expression "in classes IV and VI and the Chief Educational Officer is the competent authority in respect of class V", shall be substituted.
