School Education – Announcement made by the Hon'ble Chief Minister on 07.05.2022 under Rule 110 of Tamil Nadu Legislative Assembly – Establishment of 28 Schools of Excellence in the academic year 2022-23 – Orders – Issued.

### **ORDER**

The Hon'ble Chief Minister has made the following announcement on the floor of the Tamil Nadu Legislative Assembly under Rule 110 of Tamil Nadu Legislative Assembly on 07.05.2022.

"I have personally visited the (Model) Schools in New Delhi which is under the control of the Government of New Delhi from last April. The Chief Minister of New Delhi also came along with me and enthusiastically explained about the School of Excellence. I have assured him that we will create such schools in Tamil Nadu. On that basis, I am very happy to announce that Schools of Excellence will be created in Tamil Nadu.

Initially, 25 Municipal and Government Higher secondary School will be upgraded at an estimate of Rs.150 crore. In these schools, buildings, basic amenities would be renovated and new amenities would be created. Priority will be given to learning activities of students that includes arts, literature, music, dance, practical science, science, games, handicrafts facilities. An inclusive structure will be created. Multitalented personalities of the students will be brought out. Students' individual talent will be identified and their personality development would be enhanced. I assure that this type of school will be expanded gradually in all districts in the State."

2. In order to implement the announcement made by the Hon'ble Chief Minister on 07.05.2022 under Rule 110 of Tamil Nadu Legislative Assembly, in the letter read above, the Commissioner of School Education has sent the proposal along with budget details and stated that 28 schools across the State would be transformed into Schools of Excellence. These schools will be in operation from the Academic year 2022-23 and also stated that Rs.171,07,53,600/- is required for upgrading and administering 28 Schools of

Excellence, in which a project proposal for an amount of Rs.68,60,16,000/- has already been submitted for sanction of funds under the NABARD. Hence, the Commissioner of School Education has requested the Government to issue administrative sanction for an amount of Rs.102,47,37,600/- (Rupees One hundred and two crore forty seven lakh thirty seven thousand and six hundred only) by excluding the fund proposed to sanction under the NABARD for establishing 28 Schools of Excellence from the Academic Year 2022-23.

The Government have carefully examined the proposal of the Commissioner of School Education in detail and accord administrative sanction for an amount of Rs.169,42,36,000/- and financial sanction of Rs.100,82,20,000/- (Rupees One hundred crore eighty two lakh and twenty thousand only) (by excluding the fund proposed to be sanctioned under the NABARD) for the establishment of 28 Schools of Excellence in the academic year 2022-23. The balance amount of Rs.68,60,16,000/- will be sanctioned after getting approval from the NABARD under RIDF XXVIII for the year 2022-23.

6. The expenditure of Rs.100,82,20,000/- sanctioned in para-3 above will constitutes an item of “New Instrument of Service”. The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Commissioner of School Education is directed to calculate the actual amount required for the period upto next Supplementary

Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form 'A' appended to Tamil Nadu Contingency Funds Rules, 1963 along with a copy of this order. Orders for sanction of advance from the Contingency Fund will be issued from Finance (BG-I) Department. The Commissioner of School Education is also requested to send necessary explanatory notes for inclusion of the above, expenditure in the Supplementary Estimates 2022-23 to Finance (BG-I / Edn-II) Department at an appropriate time without fail.
