ORDER:-

The post of Special Teachers is outside the purview of the Tamil Nadu Public Service Commission and is covered by the Tamil Nadu School Educational Subordinate Service Special Rules. The existing policy of recruiting the Special Teachers is through Teachers Recruitment Board by following the method of seniority in Employment Exchange with Communal Rotation.

- 2. In the year 2012, the Teachers Recruitment Board had initiated the selection process for filling up of the 1028 posts of Special Teachers (Physical Education) sanctioned vide G.O.(Ms)No.64, School Education (C2) Department, dated 15.03.2010, G.O.(Ms.)No.152, School Education (Bud) Department, dated 03.06.2010 and G.O.(Ms.)No.169, School Education (Bud) Department, dated 02.11.2011. The Teachers Recruitment Board published the tentative list of selected candidates as per the State-wide seniority in Employment Registration.
- 3. One Thiru.P.Muthuvalan, who was one of the candidates sponsored by the Employment Exchange under the Land Acquisition Priority Category in the Most Backward Class Communal Turn was aggrieved as he was not selected. Hence, he filed a Writ Petition No.11663/2012 in the Madurai Bench of Madras High Court praying for the issuance of Writ of certiorarified mandamus to call for the records relating to the order not selecting him for the post of Physical Education Teacher and requested to quash the same and further direct the Teachers Recruitment Board to select and appoint him as Physical Education Teacher.
- 4. The Hon'ble Madurai Bench of Madras High Court in its order dated 12.10.2012 has issued the following direction:-

"directing the respondents to fill up the post of Special Teacher (Physical Education) by inviting applications from all eligible persons by publication in

press in addition to the names sponsored by the employment exchange and thereafter, select the candidates on merits. According to the criteria adopted by the first respondent, the criteria be decided before process of selection starts it shall be open to respondent No.1 to have written test followed by interview / viva-voce".

- 5. In view of the orders of the Hon'ble Madurai Bench of Madras High Court referred in para-4 above and in order to proceed the recruitment of Special Teachers (Physical Education, Drawing, Sewing & Music), the Member Secretary, Teachers Recruitment Board has requested the Government to issue guidelines for the recruitment and appointment to the post of Special Teachers (Physical Education, Drawing, Sewing and Music).
- 6. The Government after careful consideration, accept the request of the Member Secretary, Teachers Recruitment Board and accordingly issue the following modalities for the recruitment and appointment to the post of Special Teachers (Physical Education, Drawing, Sewing and Music) as follows:-
 - The existing system of recruitment following the criteria of Seniority in Employment Registration be replaced with written competitive examination.
 - ii) Applications shall be invited from eligible persons by open advertisement in the newspaper and from the candidates sponsored by the employment exchange.
 - iii) The total 100 marks will be earmarked as 95 marks for written competitive examination and 5 marks for interview. Five candidates for each vacancy (who qualify in the written examination) will be called for interview.
 - iv) The State Council for Educational Research and Training will prepare the syllabi and the same will be notified in the Gazette of Tamil Nadu.
 - v) There shall be only one paper for the written competitive examination for a duration of 3 hours.
 - vi) The questions will be of objective type. The 190 questions will carry ½ (half) mark for each question thereby totalling 95 marks for the written examination.
 - vii) The Teachers Recruitment Board shall be the nodal agency for conducting the written examination and interview. The question papers for the written examination, evaluation, interview and preparation of rank list will be undertaken by the Teachers Recruitment Board. Based on the ranking and the rule of reservation, the Teachers Recruitment Board will finalize the list of candidates.

viii) The interview carries maximum of 5 marks as given below:-

- (ix) Examination Fee:- The notification call for application for recruitment of Special Teachers will be issued by the Chairman, Teachers Recruitment Board and published in the leading two newspapers, one of which shall be in vernacular language having wide circulation in the State. The Examination fee shall be Rs.500/- for candidates of all community. (Rs.250/- for SC/ST and Persons with Disabilities).
- 7. The Chairman, Teachers Recruitment Board is directed to follow the modalities for the recruitment and appointment to the post of Special Teachers (Physical Education, Drawing, Sewing and Music).
