### ORDER:-

In the Government order 1<sup>st</sup> read above orders have been issued towards the printing and supply of WHO Growth Monitoring registers to all Anganwadi Centres at the cost of ₹ 382.74 lakh for the year 2014-2015 by following Centralised Tender procedures.

2. In the letter 2<sup>nd</sup> read above the Director, Integrated Child Development Services Scheme has sent proposal stating that Tender Notification was published in the Dailies for following Centralised Tender procedure and bill for the advertisement charges to the tune of ₹ 1,02,960 has been received. As there is no availability of funds under the Head Advertisement charges, the bill could not be settled. Therefore the Director, Integrated Child Development Services Scheme has requested the Government to sanction a sum of ₹ 1,02,960 towards the advertisement cost.

3. After careful examination, Government accord sanction for a sum of ₹ 1,02,960 (One lakh two thousand nine hundred and sixty only) towards the advertisement charges to publish the tender notification / advertisement charges for Printing and Supply of WHO Growth registers.

4. The expenditure sanctioned in para 3 above shall be debited under the following head of account:-

5. The Director of Integrated Child Development Services Scheme is authorised to draw and disburse the amount sanctioned in para 3 above.
