### ORDER:

In the letter first read above, Government of India have revised the Guidelines regarding the construction of Anganwadi Centres under Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) at the cost of ₹ 7.00 lakh per Anganwadi Centre @ ₹ 5.00 lakh under MGNREGA and ₹ 2.00 lakh under Integrated Child Development Services Scheme funds which will be utilised towards the finishing of the building consisting of flooring, painting, plumbing, electrification and wood work etc., as a separate work. During the Empowered Committee Meeting of MGNREGA, Government of India have approved the construction of 1,000 Anganwadi Centres for the Financial Year 2016-2017 in convergence with Integrated Child Development Services Scheme. Accordingly, the construction of 1,000 Anganwadi Centre Buildings at the unit cost of ₹ 7.00 lakh (₹ 5.00 lakh under MGNREGA & ₹ 2.00 lakh under ICDS) has been planned during the Financial Year 2016-2017. Thus, the total contribution for the construction of 1,000 Anganwadi



Centre Buildings will amount to ₹70.00 crore (₹50.00 crore from (MGNREGA + ₹20.00 crore from ICDS). Accordingly, Rural Development and Panchayat Raj Department has approved construction of 1,000 Anganwadi Centres under MGNREGA during 2016-2017 as per minutes of the Empowered Committee, Government of India on State Rural Development Plan including Labour Budget for the State of Tamilnadu.

2. In the letter second read above, Government of India, Ministry of Women and Child Development has approved the Annual Programme Implementation Plans (APIP) 2016-2017 for a sum of ₹100.00 crore in the sharing pattern of 60:40 (Government of India share ₹60.00 crore; State share ₹40.00 crore) towards the construction of 5000 Anganwadi Centres in convergence with MGNREGA and Integrated Child Development Services Scheme funds i.e ₹5.00 lakh under MGNREGA and ₹2.00 lakh under ICDS. The above Integrated Child Development Services Scheme funds will be utilised towards the finishing of the building consisting of flooring, painting, plumbing, electrification and wood work etc., as a separate work as per the Guidelines.

3. In the letter third read above, Government of India have released a sum of ₹30.00 crore out of ₹60.00 crore as its 60% share for the construction of 2,500 Anganwadi Buildings as I Phase under MGNREGA and Integrated Child Development Services Scheme for the year 2016-2017 and the same has been credited into the State Government Account.

4. In the Government Order fourth read above, sanction was accorded to construct of 1,000 Anganwadi Centres at unit cost of ₹7.00 lakh and total cost of ₹70.00 crore under Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) in convergence with Integrated Child Development Services Scheme (ICDS). Accordingly, the expenditure has to be shared at ₹50.00 crore from Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) and ₹20.00 crore from Integrated Child Development Services Scheme as per the announcement made by the Hon'ble Chief Minister under rule 110 of Tamilnadu Legislative Assembly.

5. In the letter fifth read above, the Director, Integrated Child Development Services Scheme has sent proposal to sanction expenditure under Integrated Child Development Services Scheme towards the construction of 1,000 Anganwadi Centres in convergence with MGNREGA stating that Government of India in Department of Rural Development, (MGNREGA Division) has approved the construction of 1,000 Anganwadi Centres under MGNREGA at a cost of ₹7.00 lakh per centre i.e., ₹5.00 lakh from MGNREGA and ₹2.00 lakh from Integrated Child Development Services Scheme funds for the year 2016-2017. The Director, Rural Development and Panchayat Raj Department has accordingly issued orders to the District Collectors for construction of new buildings to 1,000 Anganwadi Centres @ ₹7.00 lakh per centre under MGNREGA in convergence with Integrated Child Development Services Scheme during 2016-2017. Since the Director of Rural Development and Panchayat Raj Department has taken up the work of construction of new buildings to 1,000 Anganwadi Centres @ ₹7.00 lakh per centre under MGNREGA in convergence with Integrated Child Development Services Scheme, the Integrated Child Development Services Scheme share of ₹20.00 crore @ of



₹2.00 lakh per centre has to be sanctioned now and therefore requested the Government to issue necessary orders.

7. After careful examination Government issue the following orders:-

- i. Sanction is accorded for a sum of ₹20.00 crore pertaining to Integrated Child Development Services Scheme share towards the construction of 1,000 Anganwadi Centres in synergy with Rural Development and Panchayat Raj Department during 2016-2017 in the sharing pattern of 60:40 between Government of India and State Government. (Government of India share ₹12,00,00,000 and State share ₹8,00,00,000).
- ii. The Director, Integrated Child Development Services Scheme shall draw and disburse the ICDS Scheme funds of ₹20.00 crore to Rural Development and Panchayat Raj Department at the appropriate time based on the progress of work for carrying out of flooring, painting, plumbing, electrification, woodwork etc., @ ₹2.00 lakh for the 1,000 Anganwadi Centres being constructed by Rural Development and Panchayat Raj Department for the year 2016-2017.
- iii. The Director, Integrated Child Development Services Scheme shall monitor the progress of the construction of 1,000 Anganwadi Centres inclusive of Integrated Child Development Services Scheme funds which will be utilised towards the finishing of the building consisting of flooring, painting, plumbing, electrification and wood work etc. as a separate work and send report to Government at regular intervals.
- iv. The Director, Integrated Child Development Services Scheme is requested to send Utilization Certificate to Government within time.

8. Necessary funds are included in the Final Supplementary Estimate 2016-2017.

9. The amount sanctioned in para 7(i) above shall be debited under the following Head of Account.

4236 – Capital Outlay on Nutrition – 80 – General – 800 Other Expenditure – VI schemes shared between State and Centre – UB – construction of Anganwadi Centres under restructured pattern of Integrated Child Development Services Scheme – 16 Major Works (DP Code No.4236-80-800-UB-1601).

10. The Director of Integrated Child Development Services Scheme is authorised to draw and place the amount sanctioned in para 7(i) above at the disposal of the Rural Development and Panchayat Raj Department as and when funds are required by the Director of Rural Development.
