ORDER:-

The Hon'ble Delhi High Court of Delhi in its order first read above, has ordered, among others, alleging misappropriation of funds by Indian Council for Child Welfare that the crèches would be required to make their claims for the period 01.04.2016 to 31.12.2016, in accordance with the scheme, by submitting the required documents to the respective State/UT Governments and the claim shall be made in the same manner and to the same authority as is being made post 01.01.2017. The procedure adopted by the respective State/UT Government for verifying the functioning of the crèches with effect from 01.01.2017 would also be adopted by them for also verifying the claims for the period 01.04.2016 to 31.12.2016. Since no grants were released by the Government of India based on the above Delhi High Court order for the period from 01.04.2016 to 31.12.2016 to Functional Creches run by Indian Council for Child Welfare, the Government of India have stated that the grant be disbursed through the respective State/UT Governments after verification of the functioning of the crèches and the claim made by the crèches in the same manner as being followed by States/UTs for the period post 01.01.2017 for which separate action is being taken by the Government.

2. In Government Order second read above, order have been issued, among other things, for taking over the 52 functional crèches previously run under Indian Council for Child Welfare (ICCW) and administrative sanction has been accorded to the

tune of ₹17,38,620 (Rupees seventeen lakh thirty eight thousand six hundred and twenty only) and financial sanction has also been accorded to the tune ₹11,59,080 (Rupees eleven lakh fifty nine thousand and eighty only) as 60% of Government India's share in respect of above crèches as fourth quarter for the year 2016-2017.

- 3. In the letter third read above, the Director cum Mission Director, Integrated Child Development Services has certified that as per schematic norms the Indian Council for Child Welfare (ICCW), Chennai is eligible to receive a sum of ₹49,48,020 towards grant for the period from 01.04.2016 to 31.12.2016 for 49 crèches. As per Audited Accounts furnished by the Indian Council for Child Welfare (ICCW) a sum of ₹30,95,673 is actually incurred by them. Since a sum of ₹4,89,647 is available with them towards unspent balance amount as recurring grant for the period ending 31.05.2018 the Director cum Mission Director, Integrated Child Development Services has requested to sanction a sum of ₹26,06,026 (Rupees Twenty six lakh six thousand and twenty six only) as 90% of Government of India's share towards reimbursement of grants-in-aid to Indian Council for Child Welfare (ICCW), Chennai in respect of 49 crèches run by them under National Creche Scheme for the period 01.04.2016 to 31.12.2016.
- 4. After careful examination of the proposal of the Director cum Mission Director, Integrated Child Development Services, the Government accord sanction for a sum of ₹26,06,026 (Rupees Twenty six lakh six thousand and twenty six only) as 90% of Government of India's share towards reimbursement of grants-in-aid to Indian Council for Child Welfare (ICCW), Chennai in respect of 49 crèches run by them under National Creche Scheme for the period from 01.04.2016 to 31.12.2016.
- 5. The expenditure sanctioned in para 4 above shall be debited to the following Head of Account:-

"2235-Social Security and Welfare-02-Social Welfare-102-Child Welfare-Scheme Shared between State and Centre-UD- Assistance to creches under Rajiv Gandhi National Creche Scheme (RGNCS)- 09-Grants-in-Aid - 03 - Grants for Specific Scheme". (DPC 2235-02-102-UD-0938).

- 6. The Director cum Mission Director, Integrated Child Development Services is authorized to draw the expenditure sanctioned in para 4 above and disburse the same concerned 49 functional creches under National Creche Scheme and directed to send necessary utilisation certificate to Government within time.
