ORDER:

In the letter first read above, the Government of India, have approved a new scheme viz: Indira Gandhi Matritva Sahyog Yojana (IGMSY), a Conditional Maternity Benefit (CMB) Scheme for pregnant and lactating women on pilot basis in 52 selected districts across the country by providing cash incentives for improved health and nutrition to pregnant and lactating mothers by using the Integrated Child Development Services platform. In the above scheme, the beneficiaries (Pregnant and lactating women) will be paid Rs.4,000/- in three instalments i.e. Rs.1,500/- at the end of second trimester, Rs.1,500/ will be paid 3 months after delivery and Rs.1,000/- will be paid 6 months after delivery on fulfilling certain specific conditions related to maternal and child

health as approved by Government of India. The Government of India has approved two districts i.e. Cuddalore and Erode for implementation of the above new scheme in Tamil Nadu on pilot basis.

- 2. In the letter 2nd read above, the Government of India have accorded its concurrence to implement the Indira Gandhi Matritva Sahyog Yojana scheme of the Government of India using the Integrated Child Development Services platform in synergy with the Dr.Muthulakshmi Reddy Maternity Benefit Scheme of the State Government and to give the maximum financial benefit to the Pregnant and Lactating Mothers so that all the targeted beneficiaries under the Indira Gandhi Matritva Sahyog Yojana in Erode and Cuddalore districts will be given financial assistance of Rs.12,000/i.e. Rs.4,000/- from Government of India fund and Rs.8,000/- from State Government fund and will be released in three instalments as per the conditions envisaged in the Indira Gandhi Matritva Sahyog Yojana.
- 3. In the Government Order 3rd read above, sanction was accorded for a sum of Rs.1357.08 lakh towards the implementation of IGMSY scheme in Cuddalore and Erode Districts for the year 2011-2012.
- 4. In the Government Order 4th read above, sanction was also accorded for a sum of Rs.578.405 lakh towards the implementation of IGMSY during 2012-2013 from April 2012 to September 2012 as per the Government of India revalidation order for the unspent balance.
- 5. In the Letter 5th read above, Government of India have released a sum of Rs.1,977.36 Lakh for the year 2013-2014 towards the implementation of IGMSY.
- 6. In the letter 6th read above, the Principal Secretary/Commissioner, Integrated Child Development Services Scheme has sent proposal to sanction a sum of Rs.851.715 lakh towards the cash benefit to 1,07,121 beneficiaries for the implementation of IGMSY (CMS) in Cuddalore and Erode Districts based on Utilization Certificate submitted by Director of Public Health and Preventive Medicine for the year 2012-2013 from October 2012 to March 2013 and she has also stated that for the year 2012-2013, as the additional amount of Rs.851.72 lakh for the period from October 2012 to March 2013 has been incurred by the Director of Public Health and Preventive Medicine, the Principal Secretary/Commissioner, Integrated Child Development Services Scheme has to present an adjustment bill for the above amount incurred as detailed below:-

1.	General beneficiaries (80%)	Rs. 681.38 lakh
2.	Beneficiaries under Special Component Plan (19%)	Rs. 161.83 lakh
3.	Beneficiaries for Tribal Area Sub-Plan(1%)	Rs. 8.51 lakh

The Principal Secretary/Commissioner, Integrated Child Development Services Scheme has further stated that Government of India have clarified that payment is provisional and is subject to the final adjustment in the light of audited figures in actual expenditure

for the year as a whole on reimbursing the funds of Rs.851.72 Lakh for the period from October 2012 to March 2013 from the funds released by Government of India for the year 2013-2014. The Principal Secretary/Commissioner, Integrated Child Development Services Scheme has therefore, requested the Government to sanction a sum of Rs.851.715 Lakh intended for cash benefit towards the implementation of IGMSY by adjusting the above amount in the relevant Heads of Account.

- 7. After careful examination, Government issues the following orders:-
- i. Government accord sanction for a sum of Rs.851.715 lakh (Rupees Eight crore fifty one lakh seventy one thousand and five hundred only) towards the cash benefit to the 1,07,121 beneficiaries in 3 installments for the implementation of Indira Gandhi Matritva Sahyog Yojana (IGMSY) Scheme in Cuddalore and Erode Districts during the year 2012-2013 from October 2012 to March 2013 by presenting the adjustment bill under the following Heads of Account.
 - a. General beneficiary Rs.681.38 lakh (80%)

ii. The Principal Secretary/Commissioner, Integrated Child Development Services Scheme is permitted to adjust the amount sanctioned in para 7(i) above by way of presenting an adjustment bill for the year 2012-2013 to the credit of

- 8. The expenditure sanctioned in para 7(i) will be provided in FMA 2013-2014. However, this expenditure shall be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimates 2013-2014. The Principal Secretary/Commissioner, Integrated Child Development Services Scheme is requested to present necessary adjustment bill. The Principal Secretary/Commissioner, Integrated Child Development Services Scheme is requested to include the above expenditure in FMA 2013-2014 while sending the proposal to Finance (Social Welfare) Department without fail and is also send draft explanatory notes for include the above expenditure in Supplementary Estimates to Government in Finance (Social Welfare) Department without fail.
- 9. The Principal Secretary/ Commissioner, Integrated Child Development Services Scheme is permitted to furnish Utilisation Certificate and Statement of Expenditure for the year 2012-2013 from October 2012 to March 2013 to Government of India, based on the certificate furnished by the Director of Public Health and Preventive Medicine on the number of beneficiaries disbursed with cash assistance under Dr.Muthulakshmi Reddy Maternity Benefit Scheme in Cuddalore and Erode Districts during the year 2012-2013 from October 2012 to March 2013.
- 10. The Utilisation Certificate and Statement of Expenditure giving the Physical and financial performance may be sent to Government of India by the Principal Secretary/ Commissioner, Integrated Child Development Services Scheme based on the Utilisation Certificate and Statement of Expenditure furnished by the Director of Public Health and Preventive Medicine.
- 11. This order issues with the concurrence of Finance Department vide its U.O.No.77116/DS(VS)/Fin(SW)/2014, Dated.06.01.2014 and Additional Sanction Ledger No.2553 (Two thousand five hundred and fifty three).
