ORDER:-

In Government Order first read above, orders have been issued, among other things, sanctioning a sum of ₹ 10,10,00,000 (Rupees ten crore and ten lakh only) towards hiring of 404 vehicles with the provision of Global Positioning System instrument at the rate of ₹ 2.50 lakh per vehicle per annum in the sharing pattern 60:40 between the Central Government and State Government to monitor the implementation Projects of the Integrated Child Development Services for the year 2018-2019.

2. In the letter second read above, the Government of India has given administrative approval for a sum of ₹ 10,10,00,000 (Rupees Ten crore and ten lakh only) towards hiring of 404 vehicles with the provision of Global Positioning System instrument at the rate of ₹ 2.50 lakh per vehicle per

annum in the sharing pattern 60:40 between the Central Government and State Government to monitor the implementation Projects of the Integrated Child Development Services for the year 2019-2020.

3. In the letter third read above, the Director cum Mission Director, Integrated Child Development Services has stated that in order to monitor the implementation of projects of Integrated Child Development Services properly, it is necessary to continue the scheme of hiring for the usage of Integrated Child Development Services and requested to accord sanction of ₹1010.00 lakh towards hiring of 404 vehicle as per Annual Programme Implementation Plan during the year 2019-2020 and requested to authorise to draw and disburse the amount to the District Programme Officers/the Child Development Projects Officers to hire 404 vehicles at the rate of ₹2.50 lakh per vehicle by following Tamil Nadu Transparency in Tenders Act, 1998, the guidelines/schematic norms of the Government of India and conditions stipulated in para 6 (b to r) in G.O.(Ms) No.39, Social Welfare and Nutritious Meal Programme Department, Dated 26.03.2012.

4. After careful examination of the proposal of the Director cum Mission Director, Integrated Child Development Services, the Government accord sanction for a sum of ₹ 10,10,00,000 (Rupees Ten crore and ten lakh only) towards hiring of 404 vehicles with the provision of Global Positioning System instrument at the rate of ₹2.50 lakh per vehicle per annum with sharing pattern 60:40 between the Central Government and State Government (Central Government share 60% of ₹606.00 lakh and State Government share 40% of ₹404.00 lakh) to monitor the implementation Projects of the Integrated Child Development Services for the year 2019-2020 subject to the following conditions:-

- i. The Director cum Mission Director, Integrated Child Development Services is permitted to draw and disburse the amount sanctioned in para-4 above to the District Programme Officers/Child Development Project Officers concerned so as to settle the hiring charges.
- ii. The Director cum Mission Director, Integrated Child Development Services is directed to follow the Tamil Nadu Transparency in Tenders Act, 1998 and Rules 2000 for fixing hiring rate adhering to the Government of India guidelines/schematic norms and also conditions stipulated in para 6 (b to r) in G.O (Ms) No.39, Social Welfare and Nutritious Meal Programme Department, Dated 26.03.2012.

5. The expenditure sanctioned in the para 4 above shall be debited under the following head of account:-

“2236-Nutrition-02.Distribution of Nutritious food and beverages-101 - Special Nutrition Programmes- Schemes

shared between State and Centre-UC. Hiring of Vehicles under Integrated Child Development Services Schemes – 321 - Motor Vehicles- 03 – Hire Charges (D.P.C: 2236-02-101-UC-32103)
