ORDER:

In the Government Order 1st read above sanction was accorded for a sum of Rs.264.97 lakh for conducting vocational training and orientation training programme under Kishori Shakti Yojana in 23 Districts for the year 2012-2013 at the level of first installment of grants in aid released by Government of India.

2. In the letter 2nd read above, the Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme has stated that only in decentralized pattern, the District Programme Officers can select Tenderers in their Districts specialized in imparting vocational Training in area specific/District specific trades promising job placements in the district. Since this criteria is difficult to be fulfilled in Centralized pattern, she has requested the Government to issue necessary amendment orders, decentralizing the Kishori Shakti Yojana and allowing the Principal Secretary/Special Commissioner to permit the District Programme Officers to select area specific trades and to implement it through Non Governmental

Organisations/reputed institutions etc., to fulfill the major objective of the scheme i.e. empowering the Adolescent Girls to get placements in the nearby areas.

3. After careful examination of the proposal of the Principal Secretary /Special Commissioner, Integrated Child Development Services Scheme, Government have decided to issue the following amendment:

Amendment

In para 10 of the above said Government order (2D) No.31 Social Welfare and Nutritious Meal Programme Department Dated 09.10.2012 for the words "at State Level" after the words "Non Governmental Organisations/Reputed Institutions etc," the words "**at District Level**" may be substituted.
