ORDER:

Government of India have issued Guidelines for the implementation of new scheme of Kishori Shakti Yojana in 295 projects covering 23 districts as detailed below:-

- i. to improve the nutritional and health status of girls in the age group of 11-18 years;
- ii. to provide the required literacy and numeracy skills through the non-formal stream of education to stimulate a desire for more social exposure and knowledge and to help them improve their decision making capabilities;
- iii. to train and equip the adolescent girls to improve/upgrade home-based and vocational skills;

- iv. to promote awareness of health, hygiene, nutrition, family welfare, home management and child care and to take all measure so as to facilitate their marriage only after attaining the age of 18 years and if possible, even later;
- v. to gain a better understanding of their environment related social issues and the impact on their lives; and
- vi. to encourage adolescent girls to initiate various activities to be productive and useful members of the society.

This is 100% Centrally Sponsored Scheme. Government of India have approved the unit cost of ₹1,10,000 per block/project per annum to implement the Kishori Shakti Yojana Scheme.

2. In the Government order 1st read above, Government have sanctioned for a sum of ₹324.50 lakh for implementation of Kishori Shakti Yojana scheme in 295 Projects as approved by Government of India for conducting Vocational Training to the Adolescent Girls in the age group of 16-18 years and Orientation Camps to 11-15 years school dropouts and out of school going girls during 2013-2014.

3. In the letter 2nd read above, Government of India have released a sum of ₹168.76 lakh as 1st and 2nd instalments of Grants-in-aid for the implementation of Kishori Shakti Yojana Scheme during the year 2014-2015.

4. In the letter 3rd read above, the Director, Integrated Child Development Services Scheme has sent proposal to accord sanction for a sum of ₹84,70,000 for the implementation of Kishori Shakti Yojana Scheme in 77 Projects covering 6 Districts of Dindigul, Erode, Kancheepuram, Nagapattinam, The Nilgiris and Thanjavur in accordance with the release of 2nd instalment of Government of India during the year 2014-2015 @ ₹1,10,000 per project as detailed below:-

Orientation Programme for 11-15 years school dropouts and out of school going girls in the aspects of health, nutrition, legal rights and stress management etc.

1. Orientation programme :-

a) First day classes relates to health, nutrition, legal rights and stress management etc. and to conduct exhibition.

b) Second day - Field Trip (within the project) to show the places like Post office, Police station/AWCs/NMCs/Banks etc. and including Refreshment for 2 days to 30 girls (₹20 x 30 girls per day) (Training to be provided to 30 adolescent girls – 15 girls from local and 15 from nearby villages)

5. After careful examination, Government issues the following orders:-

- i. Government accord sanction for a sum of ₹84,70,000 (Rupees Eighty four lakh and seventy thousand only) for imparting Vocational Training programme through NGOs / Reputed Institutions etc. at District level by inviting Tenders as per Tamil Nadu Tender Transparency Act 1998 and Rules 2000 and to implement through the District Programme Officers / Child Development Project Officers in 77 Projects covering 6 Districts of Dindigul, Erode, Kancheepuram, Nagapattinam, The Nilgiris and Thanjavur as per the annexure to this order, depending on their training requirements in the districts. Vocational Training will be

district specific / area specific to encourage Adolescent Girls to get placements in the nearby places

ii. The District Programme Officers of Integrated Child Development Services Scheme concerned are permitted to utilise the amount drawn for providing Training kits / Information Education Communication activities, as per Government of India guidelines to the beneficiaries, through District Programme Officers / Child Development Project Officers if any, balance is left because of effective negotiations.

iii. The Director, Integrated Child Development Services Scheme is permitted to authorize the District Programme Officers/Child Development Project Officers concerned to draw and settle the amount @ ₹1,10,000 per project for 77 Projects in 6 Districts as advance under Article 99 of Tamil Nadu Financial Code Volume I for conducting the above programme and adjust the same at the Pay and Accounts Office/Treasury office as per the schematic norms.

iv. The Pay and Accounts Officer/Treasury Officer concerned are advised to honour the bill as and when presented by the District Programme Officers / Child Development Project Officers, if it is otherwise found in order.

6. The expenditure sanctioned in para 5(i) above shall be debited under the following Head of Account:-

7. The expenditure sanctioned in para 5(i) above has already been, provided in Budget Estimate 2014-2015.




