ORDER:-

In Government Order first read above, the Government have sanctioned a sum of ₹ 7,28,85,000 with certain conditions in the sharing pattern of 60:40 for hiring of 339 vehicles at ₹ 2,15,000 per vehicle per annum for monitoring the implementation of the scheme/projects of Integrated Child Development Services during the year 2017-2018.

2. In the letter second and third read above, the Government of India has raised/enhanced the amount of hiring charge from ₹ 2,15,000 to ₹ 2,50,000 per vehicle per annum and have also conveyed the administrative approval in the Annual Programme Implementation Plan 2018-2019 for total sum of ₹ 1010.00 lakh towards hiring of 404 vehicles. Further, the Government of India have also released a sum of ₹ 151.57 crore as Grants in aid under the General Integrated Child Development Services component towards the continuous implementation of Integrated Child Development Services programme for the year 2018-2019.

3. In the letter fourth read above, the Director cum Mission Director, Integrated Child Development Services has stated that in order to monitor the

implementation of Integrated Child Development Services properly, it is necessary to continue the scheme of hiring for the usage of Integrated Child Development Services Projects and requested to accord sanction of ₹ 1010.00 lakh towards hiring of 404 vehicle as per Annual Programme Implementation Plan during the year 2018-2019 and requested to authorise to draw and disburse the amount to the District Programme Officers/the Child Development Projects Officers to hire 404 vehicles at the rate of ₹ 2.50 lakh per vehicle by following Tamil Nadu Transparency in Tenders Act, 1998, the guidelines/schematic norms of the Government of India and conditions stipulated in para 6 (b to r) in G.O.(Ms) No.39, Social Welfare and Nutritious Meal Programme Department, Dated 26.03.2012.

4. After careful examination of the proposal of the Director cum Mission Director, Integrated Child Development Services, the Government accord sanction for a sum of ₹ 10,10,00,000 (Rupees Ten crore ten lakh only) to hire 404 vehicles with the provision of GPS instrument at the rate of ₹ 2.50 lakh per vehicle per annum with sharing pattern 60:40 between Government of India and State Government (GOI share 60% of ₹ 606.00 lakh and State share 40% of ₹ 404.00 lakh) for the usage of Integrated Child Development Services Projects for the year 2018-2019 subject to the following conditions:-

- i. The Director cum Mission Director, Integrated Child Development Services is permitted to draw and disburse the amount sanctioned in para-4 above to the District Programme Officers/Child Development Project Officers concerned so as to settle the hiring charges.
- ii. The Director cum Mission Director, Integrated Child Development Services is directed to follow the Tamil Nadu Transparency in Tenders Act, 1998 and Rules 2000 for fixing hiring rate, with adhering to the Government of India guidelines/ schematic norms and also conditions stipulated in para 6 (b to r) in G.O.(Ms) No.39, Social Welfare and Nutritious Meal Programme Department, Dated 26.03.2012.

5. The expenditure sanctioned in the para 4 above shall be debited under the following head of account.

"2236-Nutrition-02.Distribution of Nutritious food and beverages-101 - Special Nutrition Programmes- Schemes shared between State and Centre-UC. Hiring of Vehicles under Integrated Child Development Services Schemes – 21 - Motor Vehicles- 03 - Hire Charges (D.P.C: 2236 02 101 UC 2135)

6. Necessary additional funds of ₹ 3,02,65,000 will be provided in R.E/FMA 2018-2019. Pending provision of such funds, the Director cum Mission Director, Integrated Child Development Services is authorized to draw and disburse the amount sanctioned in Paragraph-4 above. The Director cum Mission Director of Integrated Child Development Services shall include this additional expenditure while sending the proposal to the Government in Finance (SW) Department, for inclusion in RE/FMA 2018-2019 without fail. However this expenditure shall be brought to the notice of Legislature by a specific inclusion in the Supplementary Estimates 2018-2019. The Director cum Mission Director of Integrated Child Development Services shall also send necessary draft explanatory notes to Government in

Finance (SW/BG-I) Department for inclusion in the Supplementary Estimates 2018-2019.

7. This order issues with the concurrence of Finance Department vide its U.O.No.50617/Fin(SW)/2018, Dated 12.10.2018 and with Additional Sanction Ledger No.1591 (One thousand five hundred and ninety one).
