ORDER:-

The Hon'ble Chief Minister has made an announcement under Rule 110 of the Tamilnadu Assembly Rules on the floor of the Assembly on 13.06.2018 as follows:-

“ஒருங்கிணைந்த குழந்தை வளர்ச்சிப் பணிகள் திட்டத்தின் கீழ், 54 ஆயிரத்து 439 அங்கன்வாடி மையங்கள் செயல்பட்டு வருகின்றன. இதில் 46 ஆயிரத்து 397 அங்கன்வாடி மையங்கள் சொந்த கட்டடங்களில் செயல்பட்டு வருகின்றன. நடப்பாண்டில் 860 அங்கன்வாடி மையக் கட்டடங்களில் உள்ள சிறிய மற்றும் பெரிய வகையிலான பழுதுகளை நீக்கி, சீர்படுத்துவதற்காக தலா 2 லட்சம் ரூபாய் வீதம், 17 கோடியே 20 லட்சம் ரூபாய் நிதி ஒதுக்கீடு செய்யப்படும்”

2. In the letter second read above, the Government of India have approved to upgrade 860 Anganwadi Centres at the cost of ₹ 2.00 lakh per centre in the Annual Programme Implementation Plan (APIP) for the year 2018-2019 at the total cost of ₹ 17.20 crore in the sharing pattern of 60:40 between the Government of India and State

Government and released a sum of ₹ 210.01 crore as Grants in aid under the General Integrated Child Development Services.

3. In the letter third read above, the Director cum Mission Director, Integrated Child Development Services has sent proposal to upgrade 860 Anganwadi Centres functioning in own building at the cost of ₹ 17.20 crore @ ₹ 2.00 lakh per Anganwadi Centre in the 32 Districts and requested to sanction a sum of ₹ 17,20,00,000 with the sharing pattern of 60:40 (Government of India share ₹ 10,32,00,000 + Government of Tamilnadu share ₹ 6,88,00,000) for upgrade 860 Anganwadi Centres subject to the Guidelines of Government of India and certain conditions.

4. After careful examination of the proposal of the Director cum Mission Director, Integrated Child Development Services, the Government issue the following orders:-

- i. sanction is accorded to the tune of ₹ 17,20,00,000 (Rupees seventeen crore and twenty lakh only) with the sharing pattern of 60:40 (Government of India share of ₹ 10,32,00,000 + Government of Tamilnadu share of ₹ 6,88,00,000) to carryout up-gradation and repair works in 860 Anganwadi Centres in 32 Districts as detailed in the annexure to this order.
- ii. the Director cum Mission Director, Integrated Child Development Services is permitted to make inter-district transfer of funds / works based on the actual requirement if any required, within overall financial allocation under intimation to the Government.
- iii. the Director cum Mission Director, Integrated Child Development Services is directed to carry out following item works to the Anganwadi Centres functioning in own building within allocated fund of ₹ 2.00 lakh per Anganwadi Centre:-
 - a. Laying concrete roof for the Anganwadi Centres functioning in Asbestos sheets.
 - b. Providing electrical connection including related civil works.
 - c. Provision of fan and lights wherever needed.
 - d. Construction of ramp for access to differently abled persons.
 - e. Construction / renovation of Baby Friendly Toilets.
 - f. Provision of drinking water facilities.
 - g. Provision of storage facilities.
 - h. Replacement of cement flooring with vitrified tiles.
 - i. Colour wash to the building and child friendly thematic wall paintings.
 - j. Fire safety equipments.
 - k. Solar facilities wherever applicable (preferably in hilly / remote areas)
 - l. Replacing damaged doors and windows
 - m. Construction of compound wall with gate.
- iv. the Director cum Mission Director, Integrated Child Development Services is directed to follow the Government of India's guidelines and norms under the programme.

- v. the District Project Officers, Integrated Child Development Services are directed to undertake field visits and send necessary proposal to District Collectors concerned furnishing the list of Anganwadi centers which are proposed to be upgraded. The District Project Officer ICDS, Chennai District is directed to send the proposal to the Commissioner, Greater Chennai Corporation.
- vi. the District Collectors/Commissioner of Greater Chennai Corporation is directed to prioritize the Anganwadi centers and issue in-principle sanction to the proposed works which are to be upgraded as per Annexure to this order. The implementing agencies viz., District Rural Development Agency (DRDA), Corporations, Municipalities and Town Panchayats are directed to prepare the estimate and give technical sanction. The administrative sanction will be issued by the District Collector / Commissioner of Greater of Chennai Corporation.
- vii. the Director cum Mission Director, Integrated Child Development Services is authorised to draw the amount sanctioned in para 4(i) above and place the funds at the disposal of the District Collectors and Commissioner of Greater of Chennai Corporation. The funds will be released to the implementing agency by the District Collector/ Commissioner of Greater of Chennai Corporation based on the Administrative sanction issued.
- viii. The District Collectors and Commissioner of Greater of Chennai Corporation is directed to send the progress report every month to the Director cum Mission Director, Integrated Child Development Services. On completion of work. Utilization Certificate, statement of expenditure (SoE) along with photos (before commencement of work and after completion of work) to be send to Director cum Mission Director, Integrated Child Development Services Scheme.

5. The expenditure sanctioned in the para 4(i) above shall be debited under the following head of account.

"4236-Capital outlay on Nutrition – 80 – General 800 – Other Expenditure – Schemes shared between State and Centre – UB – Construction of Anganwadi Centres under restructured pattern of Integrated Child Development Service Scheme – 16 – Major Works" (DPC: 4236-80-800-UB-1601).

6. Necessary additional funds of 17,20,00,000 will be provided in RE/FMA 2018-2019. Pending provision of such funds, the Director cum Mission Director, Integrated Child Development Services is authorized to incur the expenditure sanctioned in para 4(i) above. He is also directed to include this items of expenditure while sending the proposal to Government in Finance (SW) Department in RE/FMA 2018-2019 without fail. However, this expenditure shall be brought to the notice of Legislature by specific inclusion in the Supplementary Estimates 2018-2019. The

Director cum Mission Director, Integrated Child Development Services shall also send necessary draft explanatory notes to Government in Finance (SW/BG-I) Department for inclusion of this expenditure in the Supplementary Estimates 2018-2019 at the appropriate time without fail.

7. This order issues with the concurrence of Finance Department vide its U.O.No.53206/Fin(SW)/2018, Dated 25.10.2018 and Additional Sanction Ledger No.1721 (One thousand seven hundred and twenty one).
