
I am directed to invite your attention to the references cited and to state that it has been ordered by the Government to adjust the additional grant of Rs.500/- for Anganwadi Workers and Rs.250/- for Mini Anganwadi Workers and Anganwadi Helpers given by Government of India, w.e.f. 1.4.2008, towards the expenditure being incurred by the State Government, based on the revision of rates specified by the Government of India in the reference first cited.

2. The Government of India in the reference third cited, have stated that the honorarium of Anganwadi Worker (AWW) may be enhanced by Rs.1500/- per month on the last honorarium drawn by them and that of Anganwadi Helper (AWH) and Anganwadi Workers of Mini- Anganwadi Centres by Rs.750/- per month on the last honorarium drawn by them with effect from 1<sup>st</sup> April, 2011.

3. After careful examination, this department decided to take necessary action to transfer the additional expenditure incurred under the State Government's head of account from the additional grant given by the Government of India with effect from 1.4.2011 to the relevant head of account in which the Government of India's expenditure is booked towards the above personnel. Accordingly, the expenditure of the State Government shall be correspondingly deducted besides increasing the Government of India commitment under the relevant heads of account.

4. This letter issues with the concurrence of Finance Department vide its U.O. No.179/DS(VS)/2012, Dated. 04.05.2012.
