## ORDER:

In the Government order first read above, orders have been issued by the Government to sanction a sum of Rs.60.00 lakh as non-recurring expenditure towards the provision of Gas Connection, Gas Stove, Pressure Cooker and a Cooking platform to 1000 Anganwadi Centres under Part-II Schemes for the year 2011-2012.
