ORDER:

In the letter 1st read above, Government of India, among other things have approved the proposal for provision of uniform sarees (2 sarees @ ₹ 200 per saree, per annum) and a name tag (Badge @ ₹ 25 per badge, per annum) to Anganwadi Workers/Anganwadi Helpers and Mini Anganwadi Workers, every year under Integrated Child Development Services Scheme with sharing pattern of 90:10 between Government of India and State Government.

2. In the letter 2nd read above, the Government of India, among other things, have enhanced the rate of uniform sarees as ₹300 per Saree per annum and revised the sharing pattern from 90:10 to 75:25. The cost of Name Badges remaining the same.

- 3. In the Government order 3rd read above, sanction was accorded for a sum of ₹427.78 lakh towards the procurement and supply of 1,73,496 uniform sarees at the rate of ₹260 per saree based on the quotation received from Co-optex and Badges at the rate of ₹25 per Badge to 86,748 Anganwadi employees in sharing pattern of 75:25 for the year 2014-2015.
- 4. In the letters 4th read above, Government of India have released a sum of ₹ 358.19 crore during 2015-2016 towards the continuous implementation of Integrated Child Development Services Scheme.
- 5. In the letter 5th read above, Government of India have modified the existing sharing ratio for all components of Integrated Child Development Services Scheme, except Supplementary Nutrition (SNP), as 60:40 between Centre and States cost sharing ratio for Supplementary Nutrition Programme will remain unchanged/same at 50:50.
- 6. In the letter 6th read above, the Director, Integrated Child Development Services Scheme has sent proposal towards procurement and supply of Uniform sarees to Anganwadi Worker for the year 2015-2016 as detailed below:-

- 7. Further, the Director, Integrated Child Development Services Scheme has stated that Government of India have approved the provision of Name badges to all Anganwadi Workers, Mini Anganwadi Workers and Anganwadi Helpers @ ₹25 per badge every year. All the Anganwadi Workers and Anganwadi Helpers have been provided Name Badges for the year 2015-2016 with the validity upto June 2016. Hence Name badges need not be required for the Anganwadi employees for this year.
- 8. In the letter 7th read above, Government of India have approved the Annual Programme Implementation Plan 2015-2016 for a sum of ₹ 579.84 crore including the component of uniform sarees.

- 9. After careful examination, Government issues the following orders:-
- i. accord sanction for a sum of ₹4,27,71,000 (Rupees Four crore twenty seven lakh and seventy one thousand only) towards the procurement and supply of 1,64,504 uniform sarees to all Anganwadi Workers and Anganwadi Helpers at the rate of ₹260 per saree from Co-optex in the sharing pattern of 60:40 (Government of India share ₹2,56,62,600, State share ₹1,71,08,400 for the year 2015-2016.
- ii. The Director, Integrated Child Development Services Scheme is authorised to draw and incur the amount sanctioned in para 9(i) above as advance under Article 99 of Tamilnadu Financial Code Volume I.
- iii. The Director, Integrated Child Development Services Scheme is permitted to supply the Uniform Sarees through District Programme Officers to all Anganwadi Employees.
- iv. The Director, Integrated Child Development Services Scheme is requested to submit the Utilization Certificate in time.
 - 10. Necessary funds are provided in FMA/FSE 2015-2016.
- 11. The amount sanctioned in para 9(i) above shall be debited under the following head of account:-
