ORDER:-

In the Government order 1<sup>st</sup> read above, Government have approved certain models of Vehicles for the purchase and use of various officials inclusive of Secretaries to Government / Head of the Departments / and Collectors.

2. In the G.O.2<sup>nd</sup> read above, Government have reallocated the Ambassador Car TN 02 G 2728 to the Project Co-ordinator, World Bank assisted Integrated Child Development Services Scheme, Chennai.

3. In the G.O. 3<sup>rd</sup> read above, Government have permitted the Director, Integrated Child Development Services Scheme to sell the Vehicle No.TN-02-G-2728 at ₹ 23,000 under premature condemnation category.

4. In the letter 4<sup>th</sup> read above, the Director, Integrated Child Development Services Scheme has sent proposal to purchase New Tata Indigo Manza GLX Safire stating that a separate permanent Vehicle is essential for his office use on the replacement of TN-02-G-2728 vehicle which was already condemned and has requested the Government to sanction ₹ 5.50 lakh towards the purchase of New Tata Indigo Manza GLX Safire 90 BS-IV (Petrol) Car as per G.O.(Ms)No.1229, Home (Tr-IV) Department, Dated 21.12.2006 and also to permit him to incur the expenditure in RE/FMA.

After careful examination Government accord sanction for a sum of ₹ 5.50 lakh (Rupees Five lakh and fifty thousands only) towards the purchase of New Tata Indigo Manza GLX Safire 90 BS-IV (Petrol) Car for the official use of the Director, Integrated Child Development Services Scheme, Tharamani, Chennai-113. The Director, Integrated Child Development Services Scheme is permitted to incur the above sanctioned expenditure.

The Director, Integrated Child Development Services Scheme is requested to include additional expenditure while sending the proposal to Government for inclusion in RE/FMA 2014-2015 without fail.
