ORDER:

In the letter first read above, the Government of India, Ministry of Women and Child Development, among other things has approved the proposal of provision of uniform sarees (2 sarees @ Rs.200/- per saree, per annum) and a name tag (Badge @ Rs.25/- per badge, per annum) to Anganwadi Workers/Anganwadi Helpers and Mini Anganwadi Workers, every year under Integrated Child Development Services Scheme, with sharing pattern of 90:10 between Government of India and State Government.

2. In the Government order second read above, sanction was accorded for a sum of Rs.4,15,75,200/- to meet the expenditure towards the supply of two Sarees as uniform at the rate of Rs.200/- each for 1,03,938 beneficiaries comprising of 49,499

Anganwadi Workers, 4940 Mini Anganwadi Workers and 49499 Anganwadi Helpers, with sharing pattern of 90:10 between the Central and State Governments (Central Government share 90% = Rs.374.18 lakh, State Government share 10% = Rs.41.57 lakh) and the procurement of Sarees shall be made from "Co-optex", chennal as per the Colour and design specified.

3. In the letters third read above, the Principal Secretary/Special Commissioner, Integrated Child Development Services has requested the Government to issue necessary orders to permit her to procure 1,84,270 Uniform sarees from Co-optex, Chennai and also to provide name badges to 92135 AWWs/AWHs/Mini AWWs working in the Anganwadi centres at a total cost of Rs.391.57 lakh for the year 2011-12 as detailed below:

She has also stated that the uniform sarees will be procured from the Co-optex, Chennai and the Anganwadi Workers and Mini Anganwadi Workers will be given Blue Colour Cotton with Polyester mix saree with Golden Border and Integrated Child Development Services Scheme emblem printed at the Border. The Anganwadi Helpers will be given Dark Honey Colour Cotton with Polyester mix saree with Orange

Border and Integrated Child Development Services emblem printed at the Border and as it is "Uniform Saree", the colour for Anganwadi Workers and Anganwadi Helpers sarees will not be changed for the year 2011-12.

- 5. After careful examination of the proposal of the Principal Secretary/Special Commissioner, Integrated Child Development Services the Government accord sanction for a sum of Rs.3,68,54,000/- (Rupees Three crore sixty eight lakh and fifty four thousand only) to meet the expenditure towards the supply of 1,84,270 uniform sarees (two sarees per worker) at the rate of Rs.200/- each to 44810 Anganwadi Workers, 3772 Mini Anganwadi Workers and 43553 Anganwadi Helpers with sharing pattern of 90:10 between the Government of India and State Governments (Central Share 90% = Rs.331.69 lakh and State share Rs.36.85 lakh) and to also permit the Principal Secretary/Special Commissioner, Integrated Child Development Services to procure the uniform sarees from the Co-optex, Chennai as per the colour and design specified at para 4 above. The Government accord further sanction for a sum of Rs.23,03,375/- (Rupees Twenty three lakh three thousand three hundred and seventy five only) to procure and distribute the name badges at a cost of Rs.25/- each for all the 92135 Anganwadi Workers/Anganwadi Helpers/Mini Anganwadi Workers for the year 2011-12. The Central Share for the procurement and supply of name badges is Rs.20.73 lakh and State share is Rs.2.31 lakh.
- 6. The amount sanctioned in para 5 above shall be debited under the following heads of account:
 - i. The total cost of Rs.3,68,54,000/- towards the supply of uniform sarees to AWWs/AWHs/Mini AWWs shall debited under the following head of account:

"2236-Nutrition -02 Distribution of nutritious food and beverages -101-Special Nutrition Programmes –Schemes in the Eleventh Five Year Plan-III Centrally Sponsored –SF-Integrated Child Development Services Scheme –Phase III 46 Clothing, Tentage and Stores (D.P.Code 2236-02-101-SF-4602).

ii. The total cost of Rs.23,03,375/- towards the supply of Name Badges to AWWs/AWHs/Mini AWWs shall be debited under the following head of account:

"2236-Nutrition -02 Distribution of nutritious food and beverages -101-Special Nutrition Programme —Schemes in the Eleventh Five Year Plan-III Centrally Sponsored —SF-Integrated Child Development Services Scheme -Phase-III 24 Materials and Supplies (D.P.Code 2236-02-10 -SF-2408).

7. A sum of Rs.22,46,000/- will be provided under the head of account 2236 02 101 SF 2408 by the way of re-appropriation of funds from the head of account 2236 02 101 SF 4602 and additional provision of Rs.57,375/- for the expenditure debited in

para 6 (ii) above will be provided in F.M.A. 2011-12, Pending provision of funds in F.M.A. 2011-12 reappropriation of funds the Principal Secretary / Special Commissioner, Integrated Child Development Services is authorized to incur the above expenditure. The Principal Secretary / Special Commissioner, Integrated Child Development Services is requested to include the above expenditure in F.M.A. 2011-12, while sending the proposal to Finance (Social Welfare) Department without fail.

- 8. The Principal Secretary/Special Commissioner, Integrated Child Development Services is permitted to authorize the District Project Officers concerned to distribute the uniform sarees and also to procure and distribute the name badges to 92135 Anganwadi Workers /Anganwadi Helpers/Mini Anganwadi Workers.
- 9. The Principal Secretary/Special Commissioner, Integrated Child Development Services is requested to send the Utilization Certificate and completion report to Government as soon as the Uniform Sarees and name badges are distributed to the Anganwadi Workers, Mini Anganwadi Workers and Anganwadi Helpers.
- 10. This order issues with the concurrence of Finance Department vide its U.O.No.9/DS(VS)/FinSW/2012, dated 19.01.2012 and Additional Sanction Ledger No.1493 (One thousand four hundred and ninety three)
