ORDER :-

- i. Wherever the surplus is identified, the vacant posts in these categories of posts should not be filled up to the extent of surplus identified and
- ii. Wherever vacancies are found the vacant posts over and above surplus post should not be filled up by Direct Recruitment

2. The Principal Secretary / Special Commissioner, Integrated Child Development Services Scheme is requested to ensure that no post is kept vacant for more than six months.

3. The incumbents of the posts in the regular scale of pay are eligible to draw besides pay, the usual allowance admissible to them under the orders in force from time to time.

4. The expenditure relating to pay and allowances for the posts mentioned in the Annexure I to V to this order shall be debited to the head of account mentioned against them.
