ORDER:-

In the letter read above, the Director, Integrated Child Development Services Scheme has stated that during Biennial inspection conducted by the Personnel and Administrative Reforms Department for the period from 01.01.2009 to 30.04.2014, it was instructed to purchase a Franking Machine. However, till date the postage stamps are being used in the Department of Integrated Child Development Services Scheme. The details of the usage of postage stamps for the year 2015 is as follows:-

- 2. There is a rebate at the rate of 3% of the total stamps loaded to the Franking Machine. Hence, during the year 2015, there would be an approximate rebate of ₹2,000 per year as per the above calculation. By using the Franking Machine, overspending (for sending a single sheet ₹5 stamp is pasted) can be eliminated as there is a weighing scale is attached to it and will print the minimum amount eligible to send it by post. This may save a huge percentage of money. The stamp value will be stored via electronic method and there is no hassle of carrying the Franking Machine to the post office each time for loading stamps. Since the cost of stamp is stored inside the machine and there is no possibility of missing of stamps. It also prints the sender's address and seal the cover make the mail ready to post; which would save time and speedy delivery. The mail sent reports are self generated and can be used to countercheck the Despatch Register. Date and time will also be printed on the incoming mail as a proof that when it was received creating more transparency. Since there are no big parcel like tapals sent from this office, it would be enough to purchase a Digital Franking Machine of maximum weighing capacity of 2.5 Kgs, with a weighing scale integrated with it. Hence, the Director, Integrated Child Development Services Scheme has requested the Government to issue necessary orders.
 - 3. After careful examination Government issues the following orders:
 - i. Accord to sanction a sum of ₹ 1.25 lakh (Rupees One lakh and twenty five thousand only) towards the purchase of Digital Franking Machine which includes taxes, License Fees and any other expenditure required for installation and commissioning within the rates fixed by Directorate General of Supplies & Disposals.
 - ii. The amount sanctioned in para 3(i) above shall be debited under the following head of account:-

- iii. The Director, Integrated Child Development Services Scheme is authorized to draw and disburse the expenditure sanctioned in para 3(i) above.
- iv. The Director, Integrated Child Development Services Scheme is requested to send the Utilisation Certificate to Government within time.
