### ORDER:

3) The Government after careful examination accord sanction for further continuance of 24716 posts of Anganwadi Workers, 3168 posts of Mini Anganwadi Workers and 24716 posts of Anganwadi Helpers as detailed in the Annexure I and II to this order for the period from 01.01.2012 to 31.12.2013.

4) The expenditure relating to salary and other allowances admissible to the incumbents of the above said posts as permissible under rules in force shall be debitable under the head of account mentioned in the Annexure –I and II to this order.
