ORDER:-

In the Government Order 1st read above, orders have been issued towards further continuance for 1,08,040 temporary posts inclusive of 1,03,938 posts of Anganwadi Workers, Mini Anganwadi Workers and Anganwadi Helpers from 01.01.2013 to 31.12.2016 which were lastly continued under various Government orders.

2. In the letter 2nd read above, the Director, Integrated Child Development Services Scheme has sent proposal towards providing further continuance for the posts of Anganwadi Workers, Mini Anganwadi Workers and Anganwadi Helpers for the period of two years from 01.01.2017 to 31.12.2018 as detailed below:-

- (i) Accord sanction for further continuance of 49,499 posts of Anganwadi Workers and 4,940 posts of Mini Anganwadi Workers and 49,499 post of Anganwadi Helpers totaling to 1,03,938 posts as detailed in the annexure I & II.
- (ii) The incumbents in the above said posts are eligible to draw the special time scales of pay permissible to them besides the usual allowance admissible to them under the orders in force from time to time.
