## ORDER:

In the Government Order 1<sup>st</sup> read above, orders have been issued towards procurement and supply of Medicine kits to all Anganwadi Centres under Integrated Child Development Services Scheme for the year 2015-2016 at the cost of ₹ 519.69 lakh wherein Government have permitted to procure and supply Albendazole syrup in the proposed list of Medicine kit to all Anganwadi Centres.

2. In the letter 2<sup>nd</sup> read above, the Director of Public Health and Preventive Medicine has given concurrence to procure Albendazole tablets (400 mg) instead of Albendazole syrup (400 mg) for the children in the age group of 1 year to 5+ years attending the Anganwadi centres.

3. In the letter 3<sup>rd</sup> read above, the Director, Integrated Child Development Services Scheme has requested the Government to issue necessary amendment orders to the Annexure -II of G.O.(2D) No.22, Social Welfare and Nutritious Meal Programme (SW-7(1)) Department, Dated 04.12.2015 for procuring the Albendazole tablets (400 mg) instead of Albendazole Syrup (400 mg) within the allotted Budget amount as per the Government Order.
