ORDER:

Government of India have approved a new scheme viz: Indira Gandhi Matritva Sahyog Yojana (IGMSY), a Conditional Maternity Benefit (CMB) Scheme for pregnant and lactating women on pilot basis in 52 selected districts across the country by providing cash incentives for improved health and nutrition to pregnant and lactating mothers by using the Integrated Child Development Services platform. The Government of India have approved two districts i.e. Cuddalore and Erode for the implementation of the above new scheme in Tamil Nadu on pilot basis.

2. In the letter 1st read above, Government of India have accorded its concurrence to implement the Indira Gandhi Matritva Sahyog Yojana scheme using the

Integrated Child Development Services platform in synergy with the Dr.Muthulakshmi Reddy Maternity Benefit Scheme of the State Government.

- 3. In the letter 2^{nd} read above, Government of India have enhanced the cash benefit under IGMSY from ₹4,000 to ₹6,000 to be provided in 2 instalments @ ₹3,000 at the 3^{rd} trimester (1^{st} Instalment) and 6 months after delivery (2^{nd} Instalment).
- 4. In Government Order 3rd read above, Government have sanctioned a sum of ₹ 126.09 lakh towards setting up of State and District IGMSY Cell and Respective Committees.
- 5. In Government Order 4th read above, Government have sanctioned a sum of ₹2797.62 lakh towards the implementation of Indira Gandhi Matritva Sahyog Yojana (CMBS) in Cuddalore and Erode Districts and continuance of State and District IGMSY Cell activities for the year 2015-2016.
- 6. In the letters 5th read above, Government of India have released a sum of ₹740.37 lakh as 1st instalment towards the implementation of IGMSY for the year 2016-2017 in the sharing pattern of 60:40 and has been credited into Government Account. Government of India have also conveyed approval for revalidation of unspent balance amounting to ₹289.97 lakh of 2015-2016 available with Government of Tamilnadu for use in the current financial year 2016-2017.
- 7. In the letter 6th read above, the Director, Integrated Child Development Services Scheme has sent proposal to the tune of ₹2805.11 lakh towards the Staff salary of State and District IGMSY Cell, Expenses of the District and State IGMSY Cell activities, for the year 2016-2017 and requested the Government to issue necessary orders.
 - 8. After careful examination, Government issue the following orders:-
 - i. sanction is accorded for a total sum of ₹2805.11 lakh (Rupees twenty eight crore five lakh and eleven thousand only) towards the cash benefit for the implementation of "Indira Gandhi Matritva Sahyog Yojana" (Conditional Maternity Benefit Scheme) (₹2591.40 lakh) in Cuddalore & Erode Districts and continuance of State and District IGMSY Cell activities (₹213.71 lakh)in the sharing pattern of 60:40 (Government of India Share ₹16,83,06,000 State Share ₹11,22,04,400) as detailed in the annexure.
 - ii. The Director, Integrated Child Development Services Scheme is permitted to draw and disburse the amount of ₹213.71 lakh as advance under Article 99 of Tamilnadu Financial Code Volume I sanctioned towards the State and District Indira Gandhi Matritva Sahyog Yojana (IGMSY) Cell activities.
- iii. The Director, Integrated Child Development Services Scheme is permitted to adjust the amount sanctioned towards the cash benefit for the implementation of "Indira Gandhi Matritva Sahyog Yojana" (Conditional Maternity Benefit

Scheme) in Cuddalore and Erode Districts by way of presenting an adjustment bill for the year 2016-2017.

- 9. The amount sanctioned in para 8 (i) above shall be debited under the following heads of account

Necessary additional funds will be provided in Final Modified Appropriation 2016-2017 to meet the expenditure sanctioned in para 8(i) above by way of reappropriation from the head of account "2236 02 101 SK 09 03 (Grants for Specific Scheme) to 2236 02 101 SK 72 00 (Training) Pending re-appropriation of funds in FMA 2016-2017, the Director cum Mission Director, Integrated Child Development Services is authorized to draw and disburse the expenditure and to send necessary proposal for inclusion of re-appropriation of funds in FMA 2016-2017 to Finance (SW) Department at appropriate time without fail.
- 12. This order issues with the concurrence of Finance Department vide its U.O.No.6831/Fin(SW)/2017, Dated: 28.02.2017 and Additional Sanction Ledger No.2224 (Two Thousand Two Hundred and Twenty Four).
