ORDER:

Government of India have approved a new scheme viz: Indira Gandhi Matritva Sahyog Yojana (IGMSY), a Conditional Maternity Benefit (CMB) Scheme for pregnant and lactating women on pilot basis in 52 selected districts across the country by providing cash incentives for improved health and nutrition to pregnant and lactating mothers by using the Integrated Child Development Services platform. The Government of India have approved two districts i.e. Cuddalore and Erode for the implementation of the above new scheme in Tamil Nadu on pilot basis.

- 2. In the letter 1st read above, Government of India have accorded its concurrence to implement the Indira Gandhi Matritva Sahyog Yojana scheme using the Integrated Child Development Services platform in synergy with the Dr.Muthulakshmi Reddy Maternity Benefit Scheme of the State Government.
- 3. In the letter 2^{nd} read above, Government of India have enhanced the cash benefit under IGMSY from ₹4,000 to ₹6,000 to be provided in 2 instalments @ ₹3,000 at the 3^{rd} trimester (1^{st} Instalment) and 6 months after delivery (2^{nd} Instalment).
- 4. In Government order 3rd read above, Government have sanctioned a sum of ₹2241.36 lakh towards the implementation of Indira Gandhi Matritva Sahyog Yojana (CMBS) in Cuddalore and Erode District and continuance of State and District IGMSY Cell activities under 100% assistance of Government of India for the year 2014-2015.
- 5. In the letter 4th read above, Government of India have released a sum of ₹ 5.60 crore as 1st instalment towards the implementation of IGMSY for the year 2015-2016. In the letter 6th read above, Government of India have modified the cost sharing pattern as 60:40 from 100% between GOI and State for Indira Gandhi Matritva Sahyog Yojana (IGMSY) from the financial year 2015-2016.
- 6. In the letter 5th read above, the Director, Integrated Child Development Services Scheme has sent proposal to the tune of ₹2797.62 lakh towards the Staff salary of State and District IGMSY Cell, Expenses of the District and State IGMSY Cell activities, for the year 2015-2016 and requested the Government to issue necessary orders.
 - 7. After careful examination, Government issues the following orders:-
 - i. accord sanction for a sum of ₹2797.62 lakh (Rupees Twenty seven crore ninety seven lakh and sixty two thousand only) towards the cash benefit for the implementation of "Indira Gandhi Matritva Sahyog Yojana" (Conditional Maternity Benefit Scheme) (₹2597.04 lakh) in Cuddalore & Erode Districts and continuance of State and District IGMSY cell activities (₹200.58 lakh)in the sharing pattern of 60:40 (GOI share ₹16,78,57,200 State share ₹11,19,04,800) as detailed in the annexure.
 - ii. The Director, Integrated Child Development Services Scheme is permitted to draw and disburse the amount of ₹200.58 lakh as advance under Article 99 of Tamilnadu Financial Code Volume I sanctioned towards the State and District Indira Gandhi Matritva Sahyog Yojana (IGMSY) cell activities.
 - iii. The Director, Integrated Child Development Services Scheme is permitted to adjust the amount sanctioned towards the cash benefit for the implementation of "Indira Gandhi Matritva Sahyog Yojana" (Conditional Maternity Benefit Scheme) in Cuddalore & Erode Districts by way of presenting an adjustment bill for the year 2015-2016.
