### ORDER:

While moving the Demand for Grants in respect of Social Welfare and Nutritious Meal Programme Department for the year 2010-2011, the Minister for Social Welfare made the following announcement on the Floor of the Legislative Assembly:-

“மலைப் பகுதிகளில் உள்ள குழந்தைகள் மையங்களுக்கு தாழ்தள பெஞ்சுகள் 10 இலட்சம் ரூபாய் செலவில் வழங்கப்படும்”

2) Based on the above announcement, the Principal Secretary / Special Commissioner, ICDS has sent proposal to the Government stating that, 24 blocks in 10 districts covering 1000 Anganwadi Centres are located in hilly areas and nearly 20552 children are benefitted from these Anganwadi Centres and to provide 4 floor benches to each Anganwadi Centre for 1000 Anganwadi Centres totaling 4000 wooden floor benches as follows:

3) The Principal Secretary / Special Commissioner, ICDS has requested the Government to sanction a sum of Rs.10.00 lakhs pending provision of funds in R.E.2010-2011 and authorize the District Programme Officers to procure 4 floor benches to each centre as per annexure and permit the Principal Secretary/ Special Commissioner, ICDS to settle the bills after verifying the stock entry certificate from District Programme Officers.

4) The Government after careful consideration have decided to accept the proposal of the Principal Secretary / Special Commissioner, ICDS and accord sanction for a sum of Rs.10.00 Lakhs (Rupees Ten Lakhs only) towards the expenditure to procure 4000 wooden floor benches, for 1000 Anganwadi Centres as per Annexure to this order (4 benches per Anganwadi Centre at the rate of Rs.250/- per wooden floor bench) in relaxation of the ban order on purchase of wooden furniture issued in G.O.(Ms).No.66, Environment and Forest Department, dated 18.8.1988 and following due Tender procedure as per the Tamil Nadu Transparency in Tender Act 1998 and Rule 2000. This case should not be quoted as precedent in future.

5) The expenditure sanctioned in para 4 above shall be debited under the following head of account:-

5) Necessary funds will be provided in FMA 2010-2011 under the above head of account. Pending provision of funds in F.M.A. 2010-2011, the Principal Secretary / Special Commissioner, ICDS is permitted to incur the expenditure sanctioned in para 4 above. The District Programme Officers concerned are authorized to procure the wooden floor benches in respect of their districts and furnish necessary report on stock entry details to the Principal Secretary / Special Commissioner, ICDS. The Principal Secretary / Special Commissioner, ICDS is permitted to settle the bills after verifying the stock entry certificate from the District Programme Officers. The Principal Secretary / Special Commissioner, ICDS is directed to include the above expenditure, while sending proposal for FMA 2010-2011 to Government in Finance Department, without fail.

6) This order issues with the concurrence of Finance (SW) Department vide its U.O.No. 46/JS(GR)/11, dated.14.02.2011 and Additional Sanction Ledger No. 2003 (Two thousand and three).
