ORDER :-

In Government Order 1st read above, sanction was accorded for a sum of Rs.1357.08 lakh to implement the Indira Gandhi Matritva Sahyog Yojana Scheme of Government of India by utilising Integrated Child Development Services Scheme platform in Erode and Cuddalore Districts in synergy with Dr.Muthulakshmi Reddy Maternity Benefit Scheme of the State Government through Directorate of Public Health.

2. In the letter 3rd read above, the Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme has stated that in Para 8 of the above said Government Order, it has been stated that "the Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme is permitted to draw and disburse the amount sanctioned in Para 7(i) above through the Director of Public Health and Preventive Medicine." Consequently, the Director of Public Health and

Preventive Medicine was addressed by Integrated Child Development Services Scheme to indicate his Personal Deposit Account Number for transfer of the amount sanctioned for the year 2011-2012.

3. Further, the Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme has stated that in the reference 2nd cited, the Director of Public Health and Preventive Medicine has stated that the above sanctioned amount for the year 2011-2012 could not be transferred to Dr.Muthulakshmi Reddy Maternity Benefit Scheme, as the accounts for the year 2011-2012 have already been finalized by the Accountant General. In the said letter, he has also expressed that, operating two different Heads of Accounts under two demands in the State Budget for the same assistance will inflate the budget estimates to the extent of Rs.4,000/- per beneficiary in the 2 Districts in which the scheme is implemented and is likely to complicate the accounting procedure and hence the Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme has requested the Government to issue necessary amendment orders replacing para 8 of the said Government Order.

4. In the letter 2nd read above, the Director of Public Health and Preventive Medicine has proposed that Utilisation Certificate for the funds provided by Government of India for Indira Gandhi Matritva Sahyog Yojana may be furnished as done in the case of National Social Assistance Programme (NSAP) based on the utilization certificate furnished by the Director of Public Health and Preventive Medicine on the number of beneficiaries covered under Dr. Muthulakshmi Reddy Maternity Benefit Scheme in Cuddalore and Erode Districts. Rubber Stamp may be provided with the name "Indira Gandhi Matritva Sahyog Yojana" to all the Block Medical Officers in Cuddalore and Erode Districts for affixing on the documents related to Dr. Muthulakshmi Reddy Maternity Benefit Scheme. Utilization Certificate from the year 2012-2013 onwards may be furnished to Government of India based on the certificate furnished by the Directorate of Public Health and Preventive Medicine on the number of beneficiaries disbursed with cash assistance under Dr. Muthulakshmi Reddy Maternity Benefit Scheme in Cuddalore and Erode Districts. Government of India may be informed that the funds will be routed through State Budget once the scheme is extended to all the Districts.

5. After careful examination of the proposal of the Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme and the Director of Public Health and Preventive Medicine, Government have decided to issue the following amendment.

The following paragraph may be replaced as the para 8 of the G.O.(Ms) No.200, Social Welfare and Nutritious Meal Programme Department, Dated 26.6.2012.

- i. The Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme is permitted to adjust the amount sanctioned in para 7(i) of the

From the year 2012-2013 onwards Monthly/Quarterly/Annual Utilisation Certificate and Statement of Expenditure giving the Physical and financial performance may be sent to Government of India by the Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme based on the Utilisation Certificate and Statement of Expenditure furnished by the Director of Public Health and Preventive Medicine.
- v. The Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme is permitted to provide name seal, with the name of "Indira Gandhi Matritva Sahyog Yojana" to all the Block Medical Officers in Cuddalore and Erode Districts through the Director of Public Health and Preventive Medicine for affixing on the documents related to Dr.Muthulakshmi Reddy Maternity Benefit Scheme from the funds sanctioned for the implementation of Indira Gandhi Matritva Sahyog Yojana Scheme.
