## ORDER:

In G.O.(Ms) No.90, Social Welfare and Nutritious Meal Programme Department, dated 31.03.2010, orders were issued for imparting Job and Refresher Training to Supervisors and Administrative expenses to Middle Level Training centre, and a sum of Rs.22.50 lakhs was sanctioned against the proposal of the Principal Secretary / Special Commissioner, Integrated Child Development Services Scheme for sanction of Rs.24.92 lakhs restricting certain expenditure towards the Honorarium of certain staff of MLTC.

2) In the letter 2<sup>nd</sup> read above the Honorary General Secretary, Indian Council for Child Welfare has stated that the salaries sanctioned for certain staff of MLTC are below the Government of India's Revised Financial norms w.e.f. 1.4.2009, and she has requested to release the balance amount of

- Rs.2.42 lakhs, enclosing the Government of India guidelines for justifying the payment of salary and Honorarium to the staff of MLTC.
- 3) In the letter 3<sup>rd</sup> read above Principal Secretary / Special Commissioner, Integrated Child Development Services Scheme has stated that as per Government of India revised norms, the amount which is to be paid to the staff based on their service is given in column (6) in the following table:-

- 5) After careful examination of the proposal of the Principal Secretary / Special Commissioner, ICDS, Government accord sanction for a sum of Rs.2.42 lakhs (Two lakhs and Forty two thousands only) being the balance amount (Rs. 12.09 lakhs Rs. 9.67 lakhs = Rs. 2.42 lakhs) for the year 2009-2010 for making payment to the staff of Middle Level Training Centre run by Indian Council for Child Welfare for Job and Refresher Training for Supervisors Conducted during 2009-2010 as per the Government of India revised financial norms.
