ORDER:

In the Government Order second read above orders were issued to follow rules of reservation in the appointment of Anganwadi employees pursuant to the judgement of High court of Madras. In Government letter fifth read above, orders were issued to

follow 3% reservation for Differently Abled persons in the recruitment of Anganwadi Workers/Mini Anganwadi Workers and Anganwadi Helpers with a condition that only Loco Motor disability (i.e) partially orthopaedically Differently Abled Persons who are capable of handling small children (below 6 years) of their own shall be appointed in all the 3% reservation categories. In the Government order seventh read above orders were issued to follow 3% reservation for the differently abled persons partially deaf and persons with lesser degree of Loco Motor disability in the appointment of Noon Meal Organisers.

- 2. In his letter 4th read above, the State Commissioner for Differently Abled Persons has requested the Government to allow 10 years of relaxation of upper age limit for the Differently Abled persons as stipulated in section 38(1) of the persons with Disabilities. (Equal opportunities, protection of Rights and Full participation) Act 1995 and in the Government order first read above.
- 3. In the Government order third read above and eleventh read above, orders have been issued fixing the minimum and maximum age for appointment for the Noon Meal Organiser and Anganwadi Centre staff respectively.
- 4. In the High Court of Madras judgement eighth read above, High Court of Madras has directed to consider the proposal seeking relaxation of upper age limit to physically Challenged persons for appointment of Anganwadi Workers and Helpers.
- 5. In the light of the above said High Court judgement, the Principal Secretary/Special Commissioner, Integrated Child Development Services in her letter ninth read above has recommended for the relaxation of upper age limit to the differently abled persons with less locomotive disability in the appointment of Anganwadi Workers only.
- 6. In the letter tenth read above the Director of Social Welfare has also recommended relaxation of upper age limit for appointment of Noon Meal Organiser for differently abled person as specified in the Government order seventh read above.
- 7. The Government carefully examined the proposal of the Principal Secretary/Special Commissioner, Integrated Child Development Services and Director of Social Welfare and in the light of the High Court Judgement and the prevailing ground situation. It was considered that the posts in Anganwadis need high physical activities as stated by the Principal Secretary/Special Commissioner, Integrated Child Development Services and the Anganwadi Centre employees are entrusted with the task of safeguarding small children in the age group of 6 months to 6 years which need brisk physical activity. The upper age limit fixed for the posts in Anganwadi centre is 35. If this age is increased by five years for Differently Abled persons, they will be 40 years old at the time of entry into service. At this age, it will be difficult for them to handle the tasks vested with them. Hence the Government have decided that relaxation of 3 years in the upper age limit may be permitted in favour of the Differently Abled persons for appointment in Anganwadi centre. Moreover the Principal Secretary/Special Commissioner, Integrated Child Development Services has proposed to restrict this age

relaxation to Anganwadi Worker only. In this regard it is considered, that having allowed 3% reservation for all the posts of Anganwadi Worker, Mini Anganwadi Worker and Anganwadi Helper, the relaxation of upper age limit cannot be restricted to Anganwadi Worker only. It has to be extended to all reserved categories of Differently Abled Persons.

- 8. Further, since the upper age fixed for Noon Meal Organiser post is already high at 40 years, the Government have decided that a relaxation of 3 years in the upper age limit may be permitted to the Differently Abled Persons in the appointment of Noon Meal Organisers. The Government accordingly order as follows:
 - 1. The existing upper age limit stipulated in G.O.(Ms)No.110 Social Welfare and Nutritious Meal Programme Department dated 14.5.2012 in the appointment of Anganwadi Worker/Mini Anganwadi Worker/Anganwadi Helper may be relaxed by 3 years for the differently abled persons.
 - 2. The existing upper age limit stipulated in G.O.(Ms)No.163 Social Welfare and Nutritious Meal Programme Department dated 18.8.2010 for the appointment of Noon Meal Organiser may be relaxed by 3 years for the differently abled persons.
