ORDER:

Government of India have issued Guidelines for the implementation of new scheme of Kishori Shakti Yojana Scheme in 295 Projects covering 23 districts as detailed below:-

- i. to improve the nutritional and health status of girls in the age group of 11-18 years;
- to provide the required literacy and numeracy skills through the nonformal stream of education to stimulate a desire for more social exposure and knowledge and to help them improve their decision making capabilities;
- iii. to train and equip the adolescent girls to improve/upgrade home-based and vocational skills:

- iv. to promote awareness of health, hygiene, nutrition, family welfare, home management and child care and to take all measure so as to facilitate their marrying only after attaining the age of 18 years and if possible, even later;
- v. to gain a better understanding of their environment related social issues and the impact on their lives; and
- vi. to encourage adolescent girls to initiate various activities to be productive and useful members of the society.

This is 100% Centrally Sponsored Scheme. Government of India have approved the unit cost of ₹1,10,000 per block/project per annum to implement the Kishori Shakti Yojana Scheme.

- 2. In the Government orders 1st and 2nd read above, Government have sanctioned for a sum of ₹168.30 lakh towards implementation of Kishori Shakti Yojana scheme in 153 Projects covering 14 districts for imparting Vocational Training to the Adolescent girls in the age group of 16-18 years and Orientation Camps to 11-15 years school dropouts and out of school going girls during 2014-2015.
- 3. In the letter 3rd read above, Government of India have revalidated and released the unspent balance amount of ₹1.65 lakh pertaining to 2013-2014 for the implementation of Kishori Shakti Yojana Scheme during the year 2014-2015.
- 4. In the letter 4th read above, Government of India have released a sum of ₹79.01 lakh as 1st instalment of Grants-in-aid for the implementation of Kishori Shakti Yojana Scheme during the year 2015-2016. Further, Government of India have also stated as follows:-
 - I. Kishori Shakti Yojana is Centrally Sponsored Scheme in which the Centre and States/UTs both have contributions. In the above interim release, the Centre and States/UTs contributions have been calculated on a 50:50 ratio and the sanction of funds is subject to the following conditions:-
 - II. The grant-in-aid is subject to the condition that when the scheme is closed or abandoned, the proceeds from the disposal of assets built out of the whole or a portion of the grant sanctioned will be shared between the Central and State Government in proportion with their respective shares in the capital cost to assets.
 - a) The present instalment of grant being released is on adhoc basis subject to adjustment depending upon the cost sharing ratio between the Centre and States under SABLA Scheme as may be decided by the Central Government:-
 - b) The amount of grant will have to be utilised for all the components under the Schemes as per the schematic norms;
 - c) The States/UTs shall also be required to contribute adequate amount for implementation of the SABLA Scheme.
- 5. In the letter 5th read above, the Director, Integrated Child Development Services Scheme has sent proposal to accord sanction a sum of ₹1,60,60,000 @

₹1,10,000 per project for the implementation of Kishori Shakti Yojana Scheme in 146 Projects covering 10 Districts in accordance with the release of Government of India in the sharing pattern of 50:50 between Government of India and State during the year 2015-2016 as detailed below:-

- 6. After careful examination, Government issues the following orders:
 - i. Government accord sanction for a sum of ₹1,60,60,000 (Rupees One crore Sixty lakh and Sixty Thousand only) for imparting Vocational Training programme through NGOs / Reputed Institutions etc. at District level by inviting Tenders as per Tamil Nadu Tender Transparency Act 1998, Rules 2000 which will be implemented through the District Programme Officers / Child Development Project Officers in 146 Projects covering 10 Districts viz., Perambalur, Pudukottai, Sivagangai, Theni, Tirunelveli, Thiruvallur, Tuticorin, Vellore, Villupuram and Virudhunagar depending on their training requirements in the districts. Vocational Training will be district specific / area specific need to encourage Adolescent Girls to get placements in the nearby places
 - ii. The Director, Integrated Child Development Services Scheme is permitted to authorize the District Programme Officers/Child Development Project Officers concerned to draw and settle the amount @ ₹1,10,000 per project for 146 Projects in 10 Districts as advance under Article 99 of Tamil Nadu Financial Code Volume I for imparting the above programme and adjust the same at the Pay and Accounts Office/Treasury Office as per the schematic norms.
 - iii. The Director, Integrated Child Development Services Scheme is permitted to provide Training kits / Mela / Information Education Communication activities, as per Government of India guidelines to the beneficiaries if any balance is left due to effective negotiations.
 - iv. The Pay and Accounts Officer/Treasury Officer concerned is advised to honour the bill as and when presented by the District Programme Officers / Child Development Project Officers, if it is otherwise found in order.
 - v. The Director, Integrated Child Development Services Scheme is requested to send Utilization Certificate in time.
- 7. The expenditure sanctioned in para 6(i) above shall be debited under the following Head of Account:-
