### **ORDER:**

In the Government Order first read above, orders were issued for the sanction of Rs.1,51,80,000/- for modernization of 2,000 Anganwadi Centres in 31 Districts at the rate of Rs.6,390/- (non-recurring expenditure) and Rs.1,200/- (recurring expenditure) per centre for the year 2011-12.

2. In the letters second read above, the Principal Secretary/Special Commissioner, Integrated Child Development Services has stated that in TamilNadu, there are 54,439 Children Centres functioning in 31 district units in 434 projects and in order to bring smoke free atmosphere in Children Centres, they are being modernized by providing Cooker, Gas Stove, Gas Connection and Electrification from 2006-2007 onwards and till 2010-2011, 9,940 Centres have been modernized and for the year 2011-2012, an amount of Rs.151.80 lakh is provided in the Budget Estimate for

modernization of 2,000 Children Centres and has proposed to modernize 2,232 Centres covering all 31 District units. The Non-recurring cost required for modernization of one centre works out to Rs.6,000/- and the recurring cost is Rs.800/- per annum (2cylinders @ Rs.400/- per cylinder = Rs.800/-). The item wise break up details for non-recurring cost may be seen at Annexure – I and the District-wise number of centres and the amount to be allotted to each district may be seen at Annexure – II. The Principal Secretary / Special Commissioner, Integrated Child Development Services Scheme has further stated that as per Government of India rules, the cylinder cost is changing from time to time and permission may be given to utilize the amount as per latest rate at that time.

3. The Principal Secretary / Special Commissioner, Integrated Child Development Services Scheme has therefore requested the Government to accord sanction to modernize 2232 Centres at Rs.6,000/- per centre as non-recurring cost which amounts to Rs.1,33,92,000/- and Rs.800/- per centre as recurring cost which amounts to Rs.17,88,000/- at a total cost of Rs.151.80 lakh (Rupees One hundred and fifty one lakh and eighty thousand only) and to permit her to authorize the District Programme Officers to procure the items required for modernization and to do construction of platform and electrification works with locally available material and manpower following the rules laid down in Tamil Nadu Transparency in Tenders Act, 1998 and Rules 2000, and also to authorize District Programme Officers to draw the amount of non-recurring cost of Rs.133.92 lakh at the rate of Rs.6,000/- per centre as advance under Article 99 of Tamil Nadu Financial Code, Volume-I for procurement of materials and completion of other works and to incur the recurring expenditure of Rs.17.88 lakh in normal course.

4. Government have examined the proposal of the Principal Secretary/Special Commissioner, Integrated Child Development Services and accord sanction of Rs.151.80 lakh (Rupees One crore fifty one lakh and eighty thousand only) towards recurring and non-recurring expenditure for Modernization of 2232 Anganwadi Centres for the year 2011-12, as per the expenditures indicated at Annexure I and II to this order.

5. The Principal Secretary/Special Commissioner, Integrated Child Development Services is permitted to authorize the District Programme Officers to procure the items and carryout construction of platform and other works with locally available material and man power following the rules laid down in the Tamil Nadu Transparency in Tender Act, 1998 and Rules, 2000 and also to permit the District Programme Officers concerned to draw only the amount of Non-recurring cost of Rs.1,33,92,000/- at a cost of Rs.6,000/- per centre as advance under Article 99 of Tamil Nadu Financial Code Volume-I for procurement of materials and completion of other works and also to incur the recurring expenditure of Rs.17,88,000/- as per annexure I & II to this order.

6. The expenditure sanctioned at para 4 above shall be debited under the following head of account:-

"2236-Nutrition – 02 – Distribution of Nutritious Food and Beverages – 101– Special Nutrition Programmes Schemes in the Eleventh Five Year Plan – II – State Plan – JN – Tamil Nadu Integrated Child Development Services Scheme – Phase III – 24. Material and Supplies (D.P.Code 2236-02-101-JN-2401)."
