ORDER:

In the letter first read above, the Government of India, Ministry of Women and Child Development, among other things have approved the proposal for provision of uniform sarees (2 sarees @ Rs.200/- per saree, per annum) and a name tag (Badge @ Rs.25/- per badge, per annum) to Anganwadi Workers/Anganwadi Helpers and Mini Anganwadi Workers, every year under Integrated Child Development Services Scheme, with sharing pattern of 90:10 between Government of India and State Government.

2. In the Government order second read above, sanction was accorded for a sum of Rs.3,68,54,000/- to meet the expenditure towards the supply of two Sarees as uniform at the rate of Rs.200/- each for 1,84,270 beneficiaries comprising of 44,810 Anganwadi Workers, 3,772 Mini Anganwadi Workers and 43,553 Anganwadi Helpers, with sharing pattern of 90:10 between the Central and State Governments and the

procurement of Sarees shall be made from "Co-optex", Chennai as per the Colour and design specified.

3. In the letter third read above, the Principal Secretary/Special Commissioner, Integrated Child Development Services has requested the Government to issue necessary orders to permit her to procure 2,00,322 Uniform sarees from Co-optex, Chennai and also to provide name badges to 1,00,161 Anganwadi Workers/Anganwadi Helpers/Mini Anganwadi Workers at present working in the Anganwadi centres at a total cost of Rs.4,25,68,425/-for the year 2012-13 as detailed below :

4. She has also stated that the uniform sarees will be procured from the Co-optex, Chennai printed with Integrated Child Development Services Scheme emblem.

5. After careful examination of the proposal of the Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme, the Government accord sanction for a sum of Rs.4,00,64,400/- (Rupees Four crore sixty four thousand and four hundred only) to meet the expenditure towards the supply of 2,00,322 uniform

sarees (two sarees per worker) at the rate of Rs.200/- each to 52,838 Anganwadi Workers/Mini Anganwadi Workers and 47,323 Anganwadi Helpers with sharing pattern of 90:10 between the Government of India and State Governments (Central Share 90% = Rs.360.58 lakh and State share Rs.40.06 lakh) and also permit the Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme to procure the uniform sarees from the Co-optex, Chennai. The Government accord further sanction of Rs.25,04,025/- (Rupees Twenty five lakh four thousand and twenty five only) to procure and distribute the name badges at a cost of Rs.25/- each for all the 1,00,161 Anganwadi Workers/Anganwadi Helpers/Mini Anganwadi Workers for the year 2012-2013. (90% of Central Share for the procurement and supply of name badges is Rs.22.54 lakh and 10% State share is Rs.2.50 lakh).

6. The amount sanctioned in para 5 above shall be debited under the following two heads of account:

- i. **The total cost of Rs.4,00,64,400/- towards the supply of uniform sarees to Anganwadi Workers/Anganwadi Helpers/Mini Anganwadi Workers shall be debited under the following head of account:**

"2236-Nutrition -02 Distribution of nutritious food and beverages -101-Special Nutrition Programmes –Schemes in the Twelfth Five Year Plan-III Centrally Sponsored –SF-Integrated Child Development Services Scheme –Phase III 46 Clothing, Tentage and Stores (D.P.Code 2236-02-101-SF-4602).

- ii. **The total cost of Rs.25,04,025/- towards the supply of Name Badges to Anganwadi Workers/Anganwadi Helpers/Mini Anganwadi Workers shall be debited under the following head of account:**

"2236-Nutrition -02 Distribution of nutritious food and beverages -101-Special Nutrition Programme –Schemes in the Twelfth Five Year Plan-III Centrally Sponsored –SF-Integrated Child Development Services Scheme -Phase-III 24 Materials and Supplies (D.P.Code 2236-02-101-SF-2408).

7. Necessary additional provision for the expenditure sanctioned in para 5 above will be provided in RE/FMA 2012-2013. Pending provision of funds in R.E./F.M.A 2012-2013 the Principal Secretary / Special Commissioner, Integrated Child Development Services Scheme is authorized to incur the above expenditure. The Principal Secretary / Special Commissioner, Integrated Child Development Services Scheme is requested to include the above expenditure in R.E./F.M.A. 2012-13, while sending the proposal to Finance (Social Welfare) Department without fail.

8. The Principal Secretary/Special Commissioner, Integrated Child Development Services is permitted to authorize the District Project Officers concerned to distribute the uniform sarees and also to procure and distribute the name badges to 1,00,161 Anganwadi Workers /Anganwadi Helpers/Mini Anganwadi Workers.

9. The Principal Secretary/Special Commissioner, Integrated Child Development Services is requested to send the Utilization Certificate and completion report to Government as soon as the Uniform Sarees and name badges are distributed to the Anganwadi Workers, Mini Anganwadi Workers and Anganwadi Helpers.

10. This order issues with the concurrence of Finance Department vide its U.O.No.56397/Fin(SW)/2012, dated.16.10.2012 and with Additional Sanction Ledger No.1322 (One thousand three hundred and twenty two).
