ORDER:

A Scheme of awards for Anganwadi Workers has been constituted by the Government of India in two categories, one at the State level and another at the National level. The awards for Anganwadi Worker at the State level, carry a cash award for Rs.5,000/- each and a Citation. The awardees for the National level carry a cash award of Rs.25,000/- each and a Citation.

2. As per the guidelines of the Government of India, these awards have to be granted to the Anganwadi Workers selected from the nominations by a Selection Committee.

3. In the Government Order 2nd read above, orders were issued for sanction of Rs.14.70 lakh for a list of 294 Anganwadi Workers selected for State Level Award for the year 2006-07, 2007-08, 2008-09 each year 98 Anganwadi Workers (98x3=234).

4. Now the Government of India has requested the State Government to select 98 Anganwadi Workers each for the years 2009-10, and 2010-11 respectively for State Level Award and to recommend 6 Anganwadi Workers for each year for selecting 2 Anganwadi Worker each year for National Level Award for the years 2009-2010 and 2010-2011.

5. As per the guidelines issued by the Government of India, the Selection Committee consisting of the following officials was constituted for the selection of Anganwadi Workers for State Level Awards and recommending the Anganwadi Worker for National Level Awards.

6. Accordingly the Committee has selected 196 Anganwadi Worker at the rate of 98 Anganwadi Worker for each year of 2009-2010 and 2010-2011 ($98 \times 2 = 196$) and recommended 12 Anganwadi Workers to Government of India at the rate of 6 Anganwadi Worker for nomination of National Award for the year 2009-2010, 2010-2011 ($6 \times 2 = 12$).

7. The expenditure relating to the travel, boarding lodging for the Anganwadi Workers for the National Award will have to borne by the State Government from the fund released for Integrated Child Development Services Scheme and the expenditure of Rs.9.80 lakh relating to State Level Award for 196 Workers shall also be borne by the State Government from the fund released by Government of India under Integrated Child Development Services Scheme.

8. The Principal Secretary/Special Commissioner, Integrated Child Development Services has stated that the name of 12 Anganwadi Workers recommended by the selection committee for National Award has been forwarded to Government of India on 22.5.2012. The Principal Secretary/Special Commissioner, Integrated Child Development Services has requested the Government to allocate a sum of Rs.9,80,000/- (Rupees Nine Lakh eighty thousand only) towards distribution of Rs.5,000/- (Rupees five thousand only) as cash awards to 98+98 Anganwadi Workers each for the year 2009-2010 and 2010-2011 in the fund sharing ratio of 90:10 (i.e., Central share Rs.8,82,000 + state share Rs.98,000). The Principal Secretary/Special Commissioner, Integrated Child Development Services has also requested to permit her to authorize the District Programme Officers, Integrated Child Development Services concerned to draw the amount in respect of their District in advance under

Article 99 of Tamil Nadu Financial Code Volume I and to incur the expenditure pending provision of funds in RE/FMA 2012-2013.

9. The Government after careful examination of the proposal of the Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme, accept the recommendation of the Selection Committee and approve the list of 196 Anganwadi Workers selected for State Level Award under Integrated Child Development Services Scheme for the year 2009-2010 and 2010-2011 (98x2=196) as indicated in the Annexure - I and II to this order as per the guidelines of Government of India, and sanction is accorded for incurring an expenditure of Rs.9.80 lakh (Rupees Nine lakh and eighty thousand only) at the rate of Rs.5000/- per Anganwadi Worker under the funds released by Government of India for the implementation of Integrated Child Development Services Scheme.

10. The expenditure sanctioned in para 9 shall be debited under the following head of account:

2236-Nutrition-02-Distribution of Nutritious Food and Beverages-101-Special Nutrition Programmes-Schemes in the Twelfth Five year Plan-III Centrally Sponsored-SF-Integrated Child Development Services Scheme – Phase – III 59. Prizes and Awards (DP Code.2236-02-101-SF-5905)

11. The expenditure sanctioned in para 9 above will be provided in RE/FMA 2012-13. Pending provision of such funds in RE/FMA 2012-13, the Principal Secretary/Special Commissioner is permitted to authorise the District Programme Officers concerned to draw the amount in respect of their District in advance as per the number of Anganwadi Workers indicated in the Annexure I, II to this order under Article 99 of Tamil Nadu Financial Code Volume –I and to incur the expenditure and to adjust the same with proper vouchers immediately after the completion of the activity within the stipulated time as prescribed in the Tamil Nadu Financial Code Volume I with the Pay and Accounts Officers / District Treasury Offices concerned. In the event of any failure in the adjustment of temporary advances drawn, responsibilities shall be fixed against the officials concerned for the lapse and suitable action shall be initiated by the competent authority and report thereon be submitted to the Government at the appropriate stage. The District Programme Officers are also directed to render relevant statement of accounts and reports to the Principal Secretary / Special Commissioner, Integrated Child Development Services as soon as the activity is over.

12. The Pay and Accounts Officers and Treasury Officers concerned are requested to admit the bills as and when presented if otherwise found to be in order. The Principal Secretary / Special Commissioner is requested to send necessary proposal to include the said expenditure in RE/FMA 2012-2013 to Finance (SW) Department at the appropriate stage without fail.

13. The Principal Secretary / Special Commissioner, Integrated Child Development Services Scheme is requested to send the prize distribution report to the Government without fail.

14. This order issues with the concurrence of Finance (SW) Department vide its U.O. No.55859/Fin(SW)/2012, and Additional Sanction Ledger No.1317 (One thousand three hundred and seventeen) dated 16.10.2012.
