ORDER:-

In the letter 1st read above, Government of India have approved to hire 226 Vehicles for Integrated Child Development Services Scheme at the cost of ₹ 2.15 lakh per vehicle per annum and also instructed the States that Vehicles are to be used only in respect of the activities pertaining to the implementation of the Integrated Child

Development Services Scheme. Vehicles are to be hired @ ₹2.15 lakh per vehicle per year and necessary expenditure in this regard may be incurred out of the funds released for implementation of the Integrated Child Development Services Scheme from time to time.

- 2. In the letter 2nd read above, Government of India have sanctioned additional allotment of 79 vehicles to Tamilnadu Integrated Child Development Services Scheme for hiring purpose.
- 3. In the letter 3rd read above, Government of India have evolved Broad Frame Work to strengthen and restructure the Integrated Child Development Services Scheme in MISSON MODE and conveyed the revised sharing pattern of various schemes under General Integrated Child Development Services Scheme. On the basis of revised sharing pattern, the scheme of hiring vehicle/Petrol, Oil and Lubricant has been revised from 90:10 to 75:25.
- 4. In the letter 4th read above, as per the administrative approval of Government of India for the year 2014-2015 additional 14 vehicle are sanctioned totalling to 319 vehicles.
- 5. In Government Order 5th read above, Government have accorded sanction for a sum of ₹4,57,23,333 for hiring 319 vehicles during the year 2015-2016 from October 2015 to March 2016 in the sharing pattern of 75:25. Accordingly, the Director, Integrated Child Development Services Scheme has sent the Utilization Certificate stating that out of total sanctioned amount of ₹4,57,23,333, a sum of ₹2,01,50,902 was utilized for Hiring of Vehicles by the District Project Officers/Child Development Project Officers as on 31.03.2016 and the balance amount of ₹2,55,72,431 has been surrendered to the Government Account.
- 6. In the letters 6th read above, Government of India have modified the existing sharing ratio for all components of Integrated Child Development Services Scheme, except Supplementary Nutrition (SNP), as 60:40 between Centre and States. Cost sharing ratio for Supplementary Nutrition Programme will remain unchanged/same at 50:50.
- 7. In the letter 7th read above the Director, Integrated Child Development Services Scheme has proposed a sum of ₹5,89,45,833 towards hiring of 329 vehicles @ ₹2.15 lakh per vehicle during APIP 2016-2017.
- 8. Accordingly, in the letter 8th read above, Government of India have accepted the proposal of the Government towards hiring of 329 vehicles for the year 2016-2017 and conveyed administrative approval for a sum of ₹ 109365.14 lakh inclusive of ₹ 707.35 lakh towards Hiring of 329 Vehicles for the year 2016-2017 in the sharing pattern of 60:40.
- 9. In the Letters 9th read above, Government of India have released a sum of ₹70.00 crore of grants in aid under the General Integrated Child Development Services Scheme component towards the continuous implementation of ICDS programme for the year 2016-2017.

10. In the letter 10th read above, the Director, Integrated Child Development Services Scheme has sent proposal to accord sanction for a sum of ₹5,89,45,833 towards the hiring of 329 vehicles stating that in order to monitor the implementation of Integrated Child Development Services Scheme properly, it is necessary to continue the scheme of hiring of vehicles to Integrated Child Development Services Scheme. Accordingly he has furnished the total requirement of funds towards the hiring of 329 vehicles for the year 2016-2017 from June 2016 to March 2017 as detailed below:-

Hence, the Director, Integrated Child Development Services Scheme has requested the Government to sanction a sum of ₹5,89,45,833 from June 2016 to March 2017 towards the hiring of 329 Vehicles for the usage of Integrated Child Development Services Projects and to permit him to draw and to disburse the amount to District Programme Officers/Child Development Projects Officers to hire 329 vehicles at the rate of ₹2.15 lakh/vehicle by following the conditions issued in para 6 (b to r) in the G.O.(Ms) No.39, Social Welfare and Nutritious Meal Programme Department, Dated 26.03.2012 and Government of India guidelines. He has also requested the Government to permit the District Programme Officers to fix the lowest rates selected from the 3 quotations of the Taxi owners which is equivalent or less than the rate fixed by the Regional Transport Officer of the respective area stating that the existing procedures by following the rates fixed by the Committee chaired by the District Collector in para 6(a) of the G.O. is more time consuming.

- 13. After careful examination, Government issues the following orders:-
- (i) Accord sanction for a sum of ₹3,53,67,500 (Rupees Three crore fifty three lakh sixtyseven thousand and five hundered only) (60% of Government of India share is ₹2,12,20,500 and 40% of State share is ₹1,41,47,000) towards the hiring of 329 vehicles for the usage of Integrated Child Development Services Scheme Projects for the year 2016-2017 from October 2016 to March 2017.
- (ii) Government permit the Director, Integrated Child Development Services Scheme to hire 329 vehicles for the usage of Integrated Child Development Services Scheme Projects at the rate of ₹2.15 lakh per vehicle per annum as approved by Government of India.
- (iii) Government permit the Director, Integrated Child Development Services Scheme to draw and disburse the amount sanctioned in para 13(i) above to the District Programme Officers/Child Development Project Officers concerned to hire the vehicles.
- (iv) The Director, ICDS is requested to follow the existing conditions scrupulously issued in para 6(i) (b to r) in the G.O.(Ms) No.39, Social Welfare and Nutritious Meal Programme Department, Dated 26.3.2012.
- (v) The District Project Officers are permitted to fix the least rates obtaining 3 quotation from the taxi owners by adhering the lowest rate which is equivalent (or) lesser than the rate fixed by RTO of the concerned area.
- (vi) The District Project Officers concerned are permitted to place the selected least quotation stipulated in 13(v) above before the committee chaired by the District Collector for post facto approval.
- (vii) The Director, Integrated Child Development Services Scheme is requested to send necessary Utilization Certificate to the Government in time.
- 14. The expenditure sanctioned in the para 13(i) above shall be debited under the following head of account.
