### ORDER:

In the Government Order first to fifth read above, Government have issued orders to provide 2 sets of colour uniform to Anganwadi Children in the age group of 2-5 years in 10 Districts of Chennai, Vellore, Villupuram, Dindigul, Tiruchirapalli, Perambalur, Ariyalur, Nagapattinam, Theni, and Tirunelveli from 2012-2013 to 2016-2017 towards the continuous implementation of the announcement made by the then Hon'ble Chief Minister on the Floor of the Assembly during 2012-2013. The Director, Integrated Child Development Services Scheme has sent utilisation certificate stating that sanctioned amount has been fully utilized for the year 2016-2017.



2. In the letter sixth read above, the Director, Integrated Child Development Services Scheme has sent proposal stating that the scheme of "Provision of two sets of colour dresses" to Anganwadi children was introduced during 2012-2013 as per the announcement made under rule 110 of Tamil Nadu Legislative Assembly on pilot basis to motivate the parents to send their children to Anganwadi centers without any prejudice. Most of the children attending Preschool in Anganwadi centers are from economically backward families. Parents also wanted their children to wear uniform like school children which was provided by Government at free of cost. This scheme is being implemented in 10 Districts covering 3,77,946 beneficiaries during the year 2017-2018. He has furnished the district wise budget details as follows and requested the Government to issue necessary orders:-

3. The total expenditure towards providing two sets of colour uniform to Anganwadi children @ ₹ 131.25 per set including transportation charges in selected ten districts are detailed below:-

Total No. of Districts	: 10
Total Beneficiaries	: 3,77,946
Cost per set of colour uniform	: ₹ 131.25 (including Transport charges)
Cost of 2 Colour Uniform	: ₹ 131.25 x 2 = ₹ 262.50 rounded to ₹ 263
Total Expenditure	: ₹ 263 x 3,77,946 children = ₹ 9,93,99,798



4. After careful examination Government issues the following orders:-

- i. Accord sanction for a sum of ₹ 9,93,99,798 (Rupees Nine crore ninety three lakh ninety nine thousand seven hundred and ninety eight only) towards the procurement and supply of two sets of stitched readymade colour uniform @ ₹ 131.25 per set to 3,77,946 Preschool Anganwadi children in the age group of 2-5 years at Chennai, Vellore, Villupuram, Dindigul, Tiruchirapalli, Perambalur, Ariyalur, Nagapattinam, Theni, Tirunelveli Districts during the year 2017-2018.
- ii. The Director, Integrated Child Development Services Scheme is permitted to authorise the District Programme Officers / Child Development Project Officers concerned to procure and supply the stitched ready made colour uniform dresses as per the beneficiaries allotted to their Districts following Tamilnadu Transparency in Tenders Act, 1998 and Rules, 2000.
- iii. The Director, Integrated Child Development Services Scheme is permitted to authorise the District Programme Officers / Child Development Project Officers concerned to draw and disburse the amount as per their requirement to procure and supply stitched ready made Colour Uniform dresses.
- iv. The Director, Integrated Child Development Services Scheme is permitted to make inter-district transfer of Colour uniform dresses / funds based on the actual requirement (no. of beneficiaries), if required, as the beneficiaries may vary, within overall financial allocation.
- v. The Director, Integrated Child Development Services Scheme shall send necessary Utilization Certificate to Government within the time.

5. The above expenditure shall be debited under the following head of account:-

"2236-Nutrition-02-Distribution of Nutritious food and beverages – 101 Special Nutrition programmes – State's Expenditure - JN Tamilnadu Integrated Child Development Services Scheme – Phase III – 46 Clothing, Tentage and Stores. (D.P.C. 2236-02-101-JN-4605)

6. The expenditure sanctioned above shall not constitute an item of "New Service". However, it shall be brought to the notice of the legislative by a specific inclusion in the Supplementary Estimates for 2017-2018. Necessary additional funds of ₹ 58,38,798 will be provided in RE/FMA 2017-2018. Pending provision of such funds, the Director of Integrated Child Development Services Scheme is authorized to draw and disburse the amount sanctioned in paragraph 4(i) above. The Director of Integrated Child Development Services Scheme shall include this expenditure while sending the proposal to the Government in Fin (SW) Department, for inclusion in RE/FMA 2017-2018 without fail. The Director of Integrated Child Development Services Scheme shall also send necessary draft explanatory notes to Finance (SW/BG-I) Department for inclusion in the Supplementary Estimates 2017-2018 at the appropriate time without fail.
