ORDER:

In the Government Order 1st read above, orders were issued for modernisation of 5000 children centres for Rs.302.50 lakh by providing Gas connection, Gas Stove, Pressure Cooker etc. for the year 2012-2013 as per the announcement under rule 110 of Tamil Nadu Legislative Assembly Rules on the Floor of Assembly on 14.5.2012.

2. In the Government Order 2nd read above, a sum of Rs.23.50 crore have been allocated to modernize 38,842 Anganwadi Centres under MLACDS guidelines at the rate of Rs.6,050/- per Anganwadi Centre.

3. The Principal Secretary/Special Commissioner, Integrated Child Development Services in her letter 3rd read above has sent necessary proposal to Government for sanction of fund for modernisation of 2370 Anganwadi Centres. The Principal Secretary/Special Commissioner, Integrated Child Development Services has stated that the cost required for modernizing one centre works out to Rs.6400/- (inclusive of one cylinder cost at the time of getting new connection). The item wise details for non-

recurring cost and recurring cost for one cylinder is furnished in Annexure- I. District-wise proposed number of centres and amount required details are furnished in Annexure-II and she has requested the Government to accord sanction to modernize 2370 centres at a total cost of Rs.1,51,68,000/- lakh (Rupees One Crore and Fifty one lakh Sixty eight thousand only) at the cost of Rs.6400/- per centre (Rs.5950/- non-recurring cost+ Rs.450/- as recurring cost) covering all districts. Total Non-recurring cost is Rs.1,41,01,500/- lakh and Recurring cost Rs.10,66,500/- lakh. She has also stated that an amount of Rs.151.80 lakh has been provided in the B.E., for the year 2012-2013.

4. The Principal Secretary/Special Commissioner, Integrated Child Development Services has also requested the Government to permit to authorize the District Programme Officers/Child Development Project Officers to procure the necessary items and for carrying out construction of platform and other works with locally available material and manpower following the rules laid down in the Tamil Nadu Transparency in Tenders Act 1998 and Rules 2000.

5. Further, the Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme has also requested the Government to accord sanction to modernize 2370 centres at a total cost of Rs.1,51,68,000/- (Rupees one crore fifty one lakh sixty eight thousand only) @ Rs.5950/- per centre as non-recurring cost and Rs.450/- as recurring cost covering all 32 districts and to permit her to authorize District Programme officers / Child Development Project Officers to draw the amount of Rs1,51,68,000/- (Rupees One crore, fifty one lakh sixty eight thousand only) @ the cost of Rs.6400/- per centre (inclusive of one initial cylinder cost) as advance under article 99 of Tamil Nadu Financial Code Volume I for procurement of materials and completion of other works.

6. The Government, after careful examination of the proposal of the Principal Secretary/ Special Commissioner, Integrated Child Development Services Scheme, have decided to accept the proposal of the Principal Secretary / Special Commissioner ICDS and order as follows:-

- i. The Government Sanction the modernisation of 2370 Anganwadi Centres detailed in Annexure – II to this order at a total cost of Rs.1,43,38,500/- (One crore forty three lakhs thirty eight thousand and five hundred only) by restricting the cost of modernisation to Rs.6,050/- per centre. The Item wise non recurring cost and recurring cost is given in the Annexure – I to this order.
- ii. The work of modernization of Anganwadi Centres will be done under MLACDS (MLA Constituency Development Scheme), as per the revised MLACDS Guidelines issued in the Government Order second read above.
- iii. The Principal Secretary/Special Commissioner, Integrated Child Development Services Scheme is permitted to authorise the District Programme Officers/Child Development Project Officers to procure necessary items for construction of platform with locally available material and manpower following the rules laid down in the Tamil Nadu Transparency in Tenders Act, 1998 and Rules 2000.

She should closely monitor the scheme for quality of works and timely completion of the scheme.

- iv. On receipt of the list of Anganwadi Centres to be modernized from District Programme Officer, Integrated Child Development Services Scheme, for each MLA constituency, the District Rural Development Agency will undertake the usual exercise of obtaining concurrence letter from MLAs concerned. Integrated Child Development Services Scheme can also coordinate with the District Rural Development Agencies in this regard.
- v. After obtaining the concurrence letter from the concerned MLA's the Administrative sanction will be accorded by the District Collector to District Programme Officer, Integrated Child Development Services Scheme for modernization of Anganwadi Centre and simultaneously the funds will also be released to the District Programme Officer, Integrated Child Development Services Scheme for the sanctioned works.
- vi. The District Programme Officer, Integrated Child Development Services Scheme shall take up the work as per norms fixed and complete the work within the prescribed time. After completion of the work the District Programme Officer, Integrated Child Development Services Scheme should furnish the utilization certificate to the Project Director, District Rural Development Agency, concerned and also to return the unspent balance amount if any along with interest to Project Director, DRDA in order to produce the same for Audit.

7. The expenditure sanctioned at para 6 (i) above shall be debited under the following heads of account respectively in accordance with the component wise allocation of works:
