ORDER:-

In Government Order first read above, Government have issued orders towards the implementation of the New Comprehensive Health Insurance Scheme in which it was stated that the eligibility income ceiling limit will be ₹72,000 per annum per family which has to be certified by the Village Administrative Officer.

2. In Government Order second read above, Government have issued orders among others for providing Health Insurance of ₹4 lakh for a block period of 4 years (01.07.2012 to 30.06.2016) to the employees of Government Departments and their family members drawing pay in regular and special time scales with the monthly subscription of ₹150 under New Health Insurance Scheme 2012.

3. In the meeting held on 06.04.2015 and 08.04.2015 under the Chairmanship of Hon'ble Chief Minister and a meeting held on 13.04.2015 by the Hon'ble Ministers for Social Welfare and Nutritious Meal Programme Department, Higher Education Department and School Education Department with the Nutritious Meal Workers Associations, Government have interalia deliberated and decided to extend the New

Comprehensive Health Insurance Scheme for the eligible Mini Anganwadi Worker and Helper subject to the income ceiling of ₹72,000 based on their willingness.

4. In the letter third read above, the Director, Integrated Child Development Services Scheme has sent proposal stating that since Mini Anganwadi Workers /Anganwadi Helpers are coming within the annual income ceiling of ₹72,000 in accordance with norms stipulated in the New Comprehensive Health Insurance Scheme, they may also be included under the scheme and they may be exempted from the monthly subscription/recovery of ₹150 under the existing New Health Insurance Scheme.

5. Further, the Director, Integrated Child Development Services Scheme has stated that the New Comprehensive Insurance Scheme benefits will be cancelled for the Mini Anganwadi Workers / Anganwadi Helpers as and when they get promoted or as and when their gross salary per month exceeds ₹6,000 whichever is earlier and a sum of ₹150 will be recovered from their pay for the subscription.

6. After careful examination, Government direct that the New Comprehensive Health Insurance Scheme be extended to the eligible Mini Anganwadi Workers and Helpers subject to the annual income ceiling of ₹72,000 based on their willingness.

7. The above scheme benefits will automatically be cancelled as and when they are promoted/elevated to the higher post or as and when their gross salary per month exceeds ₹6,000 whichever is earlier and will be covered under the existing Health Insurance Scheme with prescribed subscription.

8. This order issues with the concurrence of Health and Family Welfare Department and Finance Department vide its U.O.No.24186/Fin(Salaries)/2015, Dated 30.04.2015.
