### ORDER:

In the Government Order 1<sup>st</sup> read above sanction was accorded for a sum of Rs.5,07,34,000/- for procurement and supply of Pre School Education Kits (Kit-B) in centralised procurement for the year 2012-2013.

2. In the letter 2<sup>nd</sup> read above, the Principal Secretary / Special Commissioner, Integrated Child Development Services Scheme has requested the Government to issue necessary amendment orders for following decentralized pattern of tender in the districts, as per Tamilnadu Transparency in Tender's Act 1998 and Rules 2000, and to permit her to distribute the funds to the districts and to authorize the District Programme Officers / Child Development Project Officers for drawal of funds as advance under Article 99 of Tamilnadu Financial Code Volume I and to adjust the bills within time.

3. After careful examination of the proposal of the Principal Secretary / Special Commissioner, Integrated Child Development Services Scheme, Government have decided to issue the following amendment.

### Amendment

"In para 9 of the said Government Order (D) No.100, Social Welfare and Nutritious Meal Programme Department, Dated 13.09.2012 after the sentence "These aspects on quality would effectively be ensured only at the Commissioner level" the following sentences will be replaced.

"The Government permit the Principal Secretary / Special Commissioner, Integrated Child Development Services Scheme to authorize the District Programme Officers / Child Development Projects Officers to procure the Pre School Kits (Kit-B) following Tamil Nadu Transparency Tender's Act 1998 and Rules 2000 and to authorize District Programme Officers / Child Development Projects Officers to draw the sanctioned amount as advance under Article 99 of Tamil Nadu Financial Code Volume – I and to adjust the bill within time

10. The Pay and Accounts Officer / Treasury Officer concerned is advised to honour the bills as and when presented by them, if it is otherwise found to be in order".
