ORDER:-

In Government Order 1st read above, Government have issued orders towards providing hill allowance and winter allowance to the Government employees working at notified hill stations.

2. In the meeting held on 06.04.2015 and 08.04.2015 under the Chairmanship of Hon'ble Chief Minister and a meeting held on 13.04.2015 by the Hon'ble Ministers for Social Welfare and Nutritious Meal Programme Department, Higher Education Department and School Education Department with Nutritious Meal Workers Association, Government have interalia deliberated and decided to provide Hill allowance and Winter allowance for Anganwadi Workers and Anganwadi Helpers working at notified Hill areas.

3. In the letter 2nd read above, the Director, Integrated Child Development Services Scheme has sent proposal stating that representations have been received from Tamilnadu Anganwadi Employees Associations demanding sanction of Hill allowance and Winter Allowance for the Anganwadi employees working in the Anganwadi centres located in the Hill areas as already sanctioned to regular Government employees. The Director, Integrated Child Development Services Scheme has requested the Government to consider the demand of the Anganwadi association on humanitarian grounds. He has also sent the requirement of funds and therefore requested the Government to issue necessary orders.

4. After careful examination Government issues the following orders:-

- i. Accord sanction of Hill allowance @ 20% of Basic Pay + Grade pay of Anganwadi Workers and Helpers per month who are working in notified Hill areas subject to the ceiling to be fixed from time to time for 12 months under Integrated Child Development Services Scheme as a special case.
- ii. Accord sanction of Winter allowance @ 5% of Basic Pay + Grade pay of Anganwadi Workers and Anganwadi Helpers per month subject to the ceiling to be fixed from time to time for 4 months applicable to Anganwadi Workers and Helpers who are working in notified Hill areas 1000 metres to 1499 metres above Mean Sea Level (MSL) under Integrated Child Development Services Scheme as a special case.
- iii. The Director, Integrated Child Development Services Scheme is requested to utilise the expenditure towards the provision of Hill Allowance and Winter Allowance to Anganwadi Workers and Helpers under the existing Head of Account and to send the requirement of additional funds if any in the ensuing Revised Estimate to Finance Department.
