ORDER:-

In the letter first read above, Government of India have approved the State Training Institute, Tharamani to impart the Job and Refresher Training to Child Development Project Officers and Instructress of Anganwadi Training Centres.

2. In the letter second read above, Government of India has conveyed the administrative sanction for various Regular Training and Other Training Programmes under State Training Action Plan (STRAP).

- 3. In the letter third read above, Government of India have released a sum of ₹280.44 lakh as first installment of its grants to Tamilnadu for the implementation of ICDS Training Programme for the year 2011-2012.
- 4. In the letter fourth read above, Government of India has revalidated its sanction so as to utilize the unspent balance amount of ₹225.07 lakh out of grants sanctioned for the year 2011-2012 for the implementation of Integrated Child Development Services Scheme Training Programme during 2013-2014.
- 5. The Director, Integrated Child Development Services Scheme has sent the proposal to sanction of ₹43,71,000 as the Administrative Cost and other recurring and non-recurring expenditure towards the strengthening of State Training Institute, Tharamani, Chennai and also to create 7 additional posts on contract basis to State Training Institute. According to the cost sharing ratio of 60:40 between Centre and State, the Government of India share is ₹ 26.23 lakh and State share is ₹ 17.48 lakh.

- 7. The Government after careful examination, issues the following orders:-
- i. The sanction is accorded for the creation of 7 posts on contract basis towards strengthening of man power of the State Training Institute as detailed in para 6 above.
- ii. The sanction is accorded for a sum of ₹43,71,000 (Rupees Forty Three lakh and Seventy One Thousand only) towards strengthening of State Training Institute. The details of the recurring, Non-recurring expenditure and the mode of recruitment of contractual posts are annexed to this order.
- iii. The Director, Integrated Child Development Services Scheme is authorized to draw and incur the above expenditure and to carry out Head-wise readjustment of financial limits wherever required within the total approved cost of the budget and
- iv. The Director, Integrated Child Development Services Scheme is permitted to fill up the proposed 7 Nos. of contractual posts on consolidated pay from the persons retired from the Integrated Child Development Services Scheme / Social Welfare Department and other relevant department.
- 8. The expenditure sanctioned in para 7 (ii) above shall be debited under the following Head of Account:-
 - "2236 Nutrition 02 Distribution of Nutritious Food and Beverages 101 Special Nutrition Programmes Central Sector Schemes SC Integrated Child Development Services Scheme 72 Training " (D.P.C. 2236 02 101 SC 7203).
- 9. Necessary funds will be provided in RE/FMA 2017-2017. Pending provision of such funds, the Director, Integrated Child Development Services Scheme of is authorized to draw and disburse the amount sanctioned in paragraph 7(ii) above. The Director, Integrated Child Development Services Scheme shall include this additional expenditure while sending the proposal to the Government in Finance (SW) Department, for inclusion in RE/FMA 2017-2018 without fail. However this expenditure shall be brought to the notice of Legislature by a specific inclusion in the Supplementary Estimates 2017-2018. The Director, Integrated Child Development Services Scheme shall send necessary draft explanatory notes to Government in Finance (SW) Department for inclusion in the Supplementary Estimates 2017-2018.

10. This order issues with the concurrence of Finance (SW) Department vide its U.O.No.20660/Fin(SW)/2017, Dated: 24.04.2017 and Additional Sanction Ledger No.301 (Three hundred and one).
