ORDER:

In the letter first read above the Government of India, Ministry of Women and Child Development have approved the State Training Action Plan proposal under Regular Training for the year 2010 - 11 with the revised financial norms of 90% funding by Government of India and 10% funding by State Government for imparting various Training to Anganwadi Workers, Anganwadi Helpers, Supervisors, Child Development Project Officers under Integrated Child Development Services Scheme in Tamil Nadu. In their letter 2rd read above, Government of India have conveyed their approval for the over all Training

Programme at a total cost of Rs. 699.46 Lakh and approved to impart Refresher Training to 30400 Anganwadi Helpers in 608 batches to a tune of Rs.237.12 lakh at Rs.39000/- per batch. In their letter 3rd read above, the Government of India have released the grant in aid of Rs.354.57 Lakh as first instalment to the State of Tamil Nadu for implementation of Integrated Child Development Services Scheme Training Programme.

- 2) In the letter 4th read above, the Government of India have revalidated the unspent balance of Grant-in-aid Rs.204.71 lakh released during 2009-10 and permitted to utilise the same during 2010-11.
- 3) In the reference 5th read above, the Principal Secretary / Special Commissioner, ICDS has sent proposal for imparting Refresher Training to Anganwadi Helpers to 28796 Anganwadi Helpers in 579 batches.
- 4) The Refresher Training is regular and routine one in the pattern of Training strategy. It would be need based and focused to update their existing knowledge, skill and attitude and shall be necessary for bringing an attitudinal change among themselves and in the community. This Refresher Training would enable the Anganwadi Helpers to clarify their doubts and improve their quality of service through a lot of sharing of experiences and put them into actions. It would also enable them to get ideas to solve their problems in the field as well as in the community and also to get many innovative ideas for service improvement. The Refresher Training would be given to those Anganwadi Helpers who have completed the Job Training and once in two years.
- 5) The Refresher training programme to the Anganwadi Helpers will be organized at the Project level by Grade-I Supervisor simultaneously in all the Projects as Tamil Nadu has a decentralized pattern of Training and also this is a non-residential training programme. Hence, number of Trainees to be trained works out to 28796 Anganwadi Helpers in 579 batches. The proposal has been restricted to the actual (TA/DA worked out for working days and not for the duration) and the total amount works out to Rs.2,03,09,650/-.
- 6) The Principal Secretary / Special Commissioner, Integrated Child Development Services Scheme has, therefore, requested the Government to accord sanction for a sum of Rs.2,03,09,650/- as per the details given in the Annexure to conduct Refresher Training to 28796 Anganwadi Helpers in 579 batches under STRAP Regular Training Programme for the year 2010-11. The sharing pattern for the above Training between Central Government and State Government will be as follows:-

- 7) The Government have examined the proposal of the Principal Secretary/ Special Commissioner, ICDS and decided to accept it and accord sanction for a sum of Rs.2,03,09,650/- (Rupees two crores three lakh nine thousand six hundred and fifty only) to impart Refresher Training to 28796 Anganwadi Helpers in 579 batches as per the details given in the Annexure to this order.
 - 8) The Government also issue the following orders:-
 - The Principal Secretary / Special Commissioner, ICDS is authorized to circulate the curriculum duly incorporating the State specific issues based on the guidelines prescribed by the Government of India to the District Programme Officers for imparting Refresher Training to Anganwadi Helpers.
 - The concerned District Programme Officers are authorized to draw the amount in advance and incur the expenditure as indicated in the Annexure under Article 99 of TNFC Volume-I and adjust the advance as per rules in force.
 - The District Programme Officers are directed to render relevant statement of accounts and reports to the Principal Secretary / Special Commissioner, ICDS as soon as the training programmes are over, so as to enable the Principal Secretary / Special Commissioner, ICDS to report to Government of India.
 - The Pay and Accounts Officer/Treasury Officer concerned are instructed to honour the bill as and when presented by the District Programme Officers concerned if it is otherwise found in order.
- 9. The expenditure sanctioned in para 7 above shall be debited under the following head of account;
