ORDER:

In Government Order 1st read above, orders were issued to sanction increments to Anganwadi employees who have completed 10 years of service from the date of their joining by considering the factual position that Anganwadi employees who have completed more than 25 years of service and freshly recruited are receiving same emoluments.

2. In the meeting held on 06.04.2015 and 08.04.2015 under the Chairmanship of Hon'ble Chief Minister and a meeting held on 13.04.2015 by the Hon'ble Ministers for Social Welfare and Nutritious Meal Programme Department, Higher Education Department and School Education Department with Nutritious Meal Workers Association, Government have interalia deliberated and decided to provide the following:-

- i. sanction of Special Increment to Anganwadi Workers and Helpers those who could not get promotion even after completing 10/20/30 years of service in a single post under Integrated Child Development Services Scheme.

ii. sanction of one increment for every two years as stagnation increment for Anganwadi Workers and Helpers who could not get promotion even after completing 30 years of service in a single post.

3. In the letter 3rd read above, the Director, Integrated Child Development Services Scheme has sent proposal to sanction special increment and stagnation increment to Anganwadi employees who have completed 10/20/30 years of service and he has therefore requested the Government to issue necessary orders in this regard.

4. After careful examination, Government issues the following orders:-

- i. Sanction of one each increment to Main/Mini Anganwadi Workers and Anganwadi Helpers for those who could not get promotion even after completing 10/20/30 years of service in a single post as a special case.
- ii. Sanction of one increment for every two years as stagnation increment to Main/Mini Anganwadi Workers and Anganwadi Helpers for those who could not get promotion even after completing 30 years of service in a single post as a special case.
- iii. The Director, Integrated Child Development Services Scheme is requested to utilise the expenditure towards the provision of above increment to Main/Mini Anganwadi Workers and Helpers under existing Head of Account and to send the additional commitment of expenditure to Finance Department if any.
