### **ORDER:**

In the Government Order first read above among others, the Government have issued orders for constitution of State Commission for Protection of Child Rights under subsections (1) and (3) of section 17 of the Commissions for Protection of Child Rights Act, 2005 (Central Act 4 of 2006) and accorded necessary financial sanction with the required staff structure. In that order, the Government have also empowered the Principal Secretary / Special Commissioner of Social Defence to act as Secretary to the

above Commission and also constituted the three members Selection Committee consisting of the following to select the Chairperson for the Commission:-

The above Government Order have been notified in the Government Gazette on 04.04.2012.

2. In the Government Order second read above the Government have also issued orders framing the Tamil Nadu Commission for Protection of Child Rights Rules, 2012 and the same has been notified in the Tamil Nadu Government Gazette Extraordinary on 28.06.2012.

3. In the Government Order third read above, the Government have issued orders appointing Tmt. Saraswathi Rangasamy as the Chairperson of the Tamil Nadu Commission for Protection of Child Rights and in the Government Order fourth read above the Government have issued orders appointing the following six candidates as Members to the Tamil Nadu Commission for Protection of Child Rights:-

3. Thiru.M.Ramachandran, Chennai

Since, the tenure of the Chairperson has expired on 17.01.2016, the Government in the Government Order fifth read above have issued orders appointing Dr.Kalyani Mathivanan, Former Vice Chancellor, Madurai Kamaraj University, Chennai as Chairperson to the Tamil Nadu Commission for Protection of Child Rights.

5. Based on the orders of the Hon'ble High Court of Madras, dated 04.11.2016 in W.P.No.21267 of 2014 and the opinion of the Advocate General, Tamil Nadu, the Government has cancelled the orders issued in Government Order fifth read above appointing Dr.Kalyani Mathivanan, Former Vice Chancellor, Madurai Kamaraj University, Chennai as Chairperson of Tamil Nadu Commission for Protection of Child Rights (TNCPCR) and the Government has given permission to the Secretary, Tamil Nadu Commission for Protection of Child Rights for press release in the dailies inviting applications for the post of Chairperson of Tamil Nadu Commission for Protection of Child Rights (TNCPCR) vide Government Order sixth read above.

6. The Secretary, Tamil Nadu Commission for Protection of Child Rights / Commissioner of Social Defence in the letter seventh read above has sent the list of eligible applicants with applications received for the post of Chairperson and Members of Tamil Nadu Commission for Protection of Child Rights to the Government for the selection of Chairperson and six other Members to Tamil Nadu Commission for Protection of Child Rights.

7. As per section 18 of the Commissions for Protection of Child Rights Act, 2005, the State Government shall by notification appoint the Chairperson and other members to the Commission and the Chairperson shall be appointed on the recommendation of a three member selection committee constituted by the State Government under the Chairmanship of the Minister in-charge of the Department dealing with children.

8. The selection committee in the meeting held on 24.04.2017 recommended the following candidates as Chairperson and six members to the Tamil Nadu Commission for Protection of Child Rights:-
