ORDER:-

In the letter first read above, Government of India have approved the State Training Action Plan (STRAP) inclusive of administrative cost for State Training Institute (STI) to the tune of ₹ 148.16 lakh during the year 2011-2012.

2. In the letter second read above, Government of India have released a sum of ₹ 280.44 lakh towards the implementation of Integrated Child Development Services Scheme training programme for 2011-2012.

3. In the Government Order third read above, Government have sanctioned a sum of ₹ 43.71 lakh towards the administrative cost, other recurring and non recurring expenditure of State Training Institute (STI), Taramani, Chennai and also created 7 additional posts on contract basis to the State Training Institute (STI).

4. In the letter fourth read above, the Director, Integrated Child Development Services Scheme has sent proposal towards the continuation of administrative cost,

honorarium to the staff, other recurring expenditure of State Training Institute (STI), Taramani, Chennai stating that the contract period of the recruited staff on contract basis will be completed on 28.2.2018. Therefore, it becomes necessary to renew/extend the contractual period for further one year (i.e.) from March 2018 to February 2019. Hence, the Director, Integrated Child Development Services Scheme has requested the Government to renew/extend the contract period of the staff from March 2018 to February 2019 and sanction the funds for recurring expenses, honorarium of contractual staff and other contingencies as per the orders issued.

5. The estimated cost for the proposal are detailed below:-

6. After careful examination, Government issue the following orders:-

- i. Continuance is accorded for the 7 additional posts sanctioned in the Government Order third read above for a further period of one year from March 2018 to February 2019.
- ii. to accord sanction for a sum of ₹27,06,000 (Rupees twenty seven lakh and six thousand only) i.e. 60% Government of India share of ₹16,23,600 and 40% State share of ₹10,82,400 towards the administrative cost, honorarium to the staff recruited, other recurring expenditure of State Training Institute, Tharamani, Chennai as per the details furnished in para 5 above.
- iii. The Director cum Mission Director, Integrated Child Development Services Scheme may be authorized to draw and incur the expenditure sanctioned above and to carry out head-wise readjustment of financial limits wherever required within the total approved cost of the budget.

7. The above sanctioned expenditure shall be debited to the following head of account:
