ORDER:

In the Government order first read above, a sum of Rs. 2,65,05,750/- at the rate of Rs.89,850/- per project was sanctioned for conducting Vocational Training and Orientation Programme to the Adolescent Girls in 295 projects covering 22 districts for the implementation of Kishori Shakti Yojana Scheme under Integrated Child Development Services Scheme for the year 2010-2011.

2. The Principal Secretary / Special Commissioner, Integrated Child Development Services, has stated that a sum of Rs.1,91,35,732/-(Rupees One crore ninety one lakh thirty five thousand seven hundred and thirty two only) has been actually utilized as on 26.12.2011. There is only an unspent amount of Rs.73,70,000/- and has also furnished utilization certificate for the year 2010-11.

3. The Principal Secretary/Special Commissioner, Integrated Child Development Services has therefore proposed to utilize a sum of Rs.73,70,000/- from the above said savings amount for conducting Health, Nutrition and Life Skill awareness camps/melas in all the 22 districts, i.e. 5 camps / melas in each Project at the rate of Rs. 5000/- per Mela/Camp (except Nilgiris). For Nilgiris, 5 Camps/ Melas at Rs.4,750/- per mela/camp (as Ooty being hilly area participation of Adolescent girls is likely to be less) and Kishori Shakti Yojana Scheme Advertisement Charges as follows:

Camps / Mela for 21 Districts @ Rs.25,000 per Project (291 Projects x Rs 25000)	Rs.72,75,000/-
Camps / Mela for One District @ Rs.23,750 per Project for 4 Projects (Nilgiris)	Rs.95,000/-
Total	Rs.73,70,000/-

She has further stated that the following activities will be carried out during the one day programme schedule:-

- ❖ Conducting Exhibition on health and nutrition
- ❖ Sensitization programmes on developing life skills and empowerment of young girls. Guest lectures/ Experts will be called in various fields like law, education, health, nutrition etc.
- ❖ Conducting Cultural activities for recreation and to bring out the hidden talents. Competitions like Quiz, low-cost recipe competition etc., and arranging games like jigsaw puzzles, musical chairs, passing the parcel etc.
- ❖ Distribution of Hand bills on Nutrition recipes and Nutrition and Health tips.

The (Health & Nutrition) Melas/Camps will be conducted at a total cost of Rs.5000/- per camp as detailed below:-.

The Principal Secretary / Special Commissioner, Integrated Child Development Services has therefore requested the Government to accord permission to spend the savings amount of a sum of Rs.73,70,000/- (Rupees Seventy three lakh seventy thousand only) towards conducting Health, Nutrition and Life Skill awareness Camps / Melas in 22 districts and also to permit her to disburse the above sanctioned amount to the District Programme Officers/ Child Development Project Officers for conducting these camps/melas in 22 districts.

5. The Government after careful examination decided to accept the proposal of the Principal Secretary/Special Commissioner, Integrated Child Development Services. Accordingly, the Government accord permission to utilize the unspent amount of Rs.73,70,018/- for the year 2010-11 for conducting Health, Nutrition and Life Skill awareness Camps/Melas to the Adolescent Girls in all the 22 districts towards the implementation of Kishori Shakti Yojana Scheme under Integrated Child Development Services Scheme for the year 2011-12 and to disburse the above amount to District Programme Officers /Child Development Project Officers for conducting the above Camps/Melas in 22 districts under Kishori Sakthi Yojana Scheme, subject to the condition that the interest accrued on the unspent amount kept in the Office Savings Bank Account shall be remitted into Government Revenue Receipt Account and also to reconcile the amount with Treasury as already drawn under Article 99 of Tamil Nadu Financial Code Volume –I and to send the Utilization Certificate to Government of India at the earliest for obtaining further release from Government of India.
