### ORDER:-

In the Government Order first and second read above, Government have transferred 944 functional crèches of the State under Rajiv Gandhi National Creche Scheme to Integrated Child Development Services Scheme which are being implemented in the sharing pattern of 60:30:10 between Centre, State and NGO and sanctioned 60% Government of India funds for the year 2017-2018.

2. In the letter 3<sup>rd</sup> read above, Government of India have released/sanctioned the first installment of funds to the tune of ₹ 2,38,85,160 as its 60% share to the State of Tamilnadu towards the implementation of 1004 functional crèches under National Creche Scheme for the year 2017-2018. The recurring and non-recurring cost for running per crèche is ₹ 1,51,600 and the sharing pattern is 60:30:10 between Centre, State and NGO till 31.03.2018.

3. In the letter 4<sup>th</sup> read above, the Director, Integrated Child Development Services Scheme has sent proposal to release for a sum of ₹ 3,21,99,840 towards 1<sup>st</sup> installment grant for the year 2017-2018 in respect of 944 functional crèches. As per

the Grants released by Government of India which has to be paid to the institutions, the Director, Integrated Child Development Services Scheme has requested the Government to issue necessary orders. The details of unit cost per crèche, 60% share of Government of India and 30% share of State are detailed below:-

4. After careful examination, Government issue to issue the following orders:-

- i. to accord sanction for a sum of ₹ 3,36,86,640 (Rupees three crore thirty six lakh eighty six thousand six hundred and forty only) @ ₹ 23,790 per creche towards the grant for the year 2017-2018 in respect of 944 functional crèches under National Creche Scheme which are transferred to Integrated Child Development Services Scheme as per Government of India instructions in the sharing pattern of 60:30:10 (60% of GOI share = ₹ 2,24,57,760 and 30% of State share = ₹ 1,12,28,880).
- ii. the Director, Integrated Child Development Services Scheme is authorized to draw and disburse the above sanctioned amount to concerned NGO running 944 functional crèches under National Creche Scheme.

5. The amount sanctioned in para 4(i) above shall be debited to the following head of account:-
