## ORDER:-

The Hon'ble Chief Minister has made an announcement on the floor of Tamilnadu Legislative Assembly under rule 110 that the First Aid Kit at the cost of ₹250.42 lakh will be procured and supplied to all Anganwadi Centers @ ₹460 per centre during the year 2014-2015.

- 2. In the letter 2<sup>nd</sup> read above based on the announcement, the Director, Integrated Child Development Services Scheme has sent proposal stating that the Government of Tamilnadu has taken decisive steps to address the nutrition and health needs of children below six years, pregnant women, lactating mothers and adolescent girls. With a strong push towards universalization of the Integrated Child Development Services Scheme, Integrated Child Development Services have been steadily extended to serve unreached habitations and under-served population of the State. Various measures have been initiated by the Government to improve health and nutrition status of children below six years, pregnant women, lactating mothers and adolescent girls. The services provided by Integrated Child Development Services Scheme have contributed to the steady decline in mortality rate of infant, maternal and children in the age group of under-five.
- The Anganwadi Center is the most peripheral and first outpost of the community. As the Anganwadi Center is providing health care and nutrition services, the

## Specification:

- Micropore: A latex-free, hypoallergenic paper tape that is gentle to the skin yet adheres well and leaves minimal adhesive residue upon removal. An economical, general purpose, breathable surgical tape. To be made Available in white colour.
- 2. <u>Handyplast</u>: An adhesive bandage is usually covered by a woven fabric, plastic, or latex strip which has an adhesive. Adhesive bandages usually have an absorbent pad, which is sometimes medicated with an antiseptic solution. Some bandages have a thin, porous-polymer coating over the pad to keep it from sticking to the wound. The bandage is applied such that the pad covers the wound and the fabric or plastic sticks to the surrounding skin to hold the dressing in place and prevent dirt from entering the wound.
- 3. <u>Bleached Guaze pad:</u> Pad is made of highly absorbent gauze. No loose cotton particles and gauze threads-sealed ends. Higher rate of blood absorption-within 2 seconds. Higher fluid retention capacity. Free from foreign matter & optical whiteners. Completely sterilized by Gamma Radiation. Long lasting sterility till package damaged or opened with broad sealing area (5mm to 8mm). Easy to open and easily tearable medical paper packing. Easy storage.12 pouches packed in mono box.
- 4. The Digital thermometer (Mercury): Easy to read LCD display, Oral and Axillary usage with on and off radio alarm. Memory features recalls the previous reading to monitor the child's progress. Long life replaceable battery included. Measureable in Fahrenheit and Centigrade. Protective storage case. Water resistant for easy cleaning.
- 5. <u>Bandage Scissor:</u> 7 inches, Shop scissors, Finger ring handle, extra fine and latex free.
- 6. First Aid Manual: Booklet Size 7 / 9 booklet Wrapper -4 pages 130GSM, Indian art paper, Inner page 32 pages 100 GSM, Core colour printing.
- 7. <u>Bag or Box for the above items:</u> The above First Aid Kit materials should be kept in a container made of suitable material and so designed to protect the contents. The box / bag should be clearly marked, the recommended marking being a white cross on a green background (Health and Safety (Safety Signs and Signals) regulations 1996).

success of any nation-wide programme would depend largely on well functioning anganwadi centres providing services of acceptable standard to the people. There is a felt need for quality management in health care delivery system by the field worker so as to make the same more effective, economical and accountable.

- 4. Hence, it is essential to provide first aid services at the anganwadi centres which caters to small children in the age group of 0 to 6 years, pregnant women, lactating mothers, adolescent girls and also the old age pensioners. By provision of first aid services in the community, the chances of someone recovering more easily or minor injuries can be cured/healed if the frontline field worker utilize the first aid knowledge to assist them at the village level immediately.
- 5. The prevalence of viral and other fever are the common ailment in the community and the provision of paracetemol syrup/tablets to the community is being implemented by the Anganwadi Worker without monitoring the temperature. Since the medication have to be provided as per the dosage and also after recording the temperature, it has been decided to provide digital thermometer to all Anganwadi Centers. The Anganwadi Workers are also provided with training in First Aid Services and the same has been incorporated in the curriculum of their training. The details of items in the First Aid Kit are as follows:

- 6. The Director, Integrated Child Development Services Scheme has therefore requested the Government to accord sanction for a sum of ₹250.42 lakh towards the procurement and supply of First Aid Kit to all Anganwadi Centers @ ₹460 per centre for the year 2014-2015 and issue necessary orders.
  - 7. After careful examination, Government issues the following orders:
    - i. accord sanction for a sum of ₹2,50,42,000 (Rupees two crore fifty lakh and forty two thousand only) towards the procurement and supply of First Aid Kit to all Anganwadi Centers @ ₹460 per centre as per Annexure-I for the year 2014-2015.
    - The Director, Integrated Child Development Services Scheme is permitted to procure and supply the First Aid Kit as per the specifications mentioned in Annexure-II following centralized tender procedures of Tamilnadu Transparency in Tenders Act, 1998 and Rules, 2000.

- iii. The Director, Integrated Child Development Services Scheme is permitted to draw and disburse the amount sanctioned in para 7(i) to the selected tenderer as per the procedures of Tamilnadu Transparency in Tenders Act, 1998 and Rules, 2000.
- iv. The Director, Integrated Child Development Services Scheme is permitted to incur the Advertisement Charges also in the overall allocated Budget.
- v. The Director, Integrated Child Development Services Scheme is requested to send necessary Utilisation Certificate to the Government in time.
- 8. The expenditure sanctioned in para 7(i) above shall be debited under the following head of account:

"2236.Nutrition. - 02. Distribution of Nutritious Food and Beverages - 101. Special Nutrition Programme - Schemes in the Twelfth Five Year Plan - III. Centrally Sponsored - SF. Integrated Child Development Services Scheme-Phase-III- 66. Medicines" (D.P. Code. 2236.02.101.SF.6600)

- 9. The expenditure sanctioned at para 7(i) will constitute an item of "New Instrument of Service" for which the approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be met initially by drawal of an advance from the Contingency Fund, for which orders will be issued by Finance (BG I) Department separately. The Director, Integrated Child Development Services Scheme is requested to apply for drawal of advance from the Contingency Fund in the prescribed format for the required quantum along with copy of this order. The Director, Integrated Child Development Services Scheme is also requested to send necessary explanatory notes to Finance Department to include the expenditure in the Supplementary Estimates 2014-2015 at the appropriate stage.
- This order issues with the concurrence of Finance Department vide its U.O.No.49995/Fin(SW)/2014, Dated.15.09.2014 and Additional Sanction Ledger No.1082 (One thousand and eighty two).
