ORDER:-

In the Government Order first to sixth read above, Government have issued orders to provide 2 sets of colour uniform to Anganwadi Children in the age group of 2-5 years in 10 Districts of Chennai, Vellore, Tiruchirapalli, Theni, Dindigul, Villupuram, Ariyalur, Perambalur, Nagapattinam, and Tirunelveli from 2012-2013 to 2017-2018 towards the continuous implementation of the announcement made by the then Hon'ble Chief Minister on the Floor of the Assembly during 2012-2013.

2. In the letter seventh read above, the Director, Integrated Child Development Services Scheme has sent proposal stating that the scheme was successfully implemented in the aforesaid districts and the feedback has been encouraging and requested to accord sanction for a sum of ₹ 9,94,53,375 to continue the scheme in the year 2018-2019. The cost and beneficiaries for provision of colour uniform for the year 2018-2019 in 10 districts is as detailed below.

3. The cost of the stitched readymade colour uniform dresses is @ ₹ 131.25 per set including the transportation and GST charges. The Director, Integrated Child Development Services Scheme has therefore requested the Government to issue necessary orders.

4. After careful examination, Government issue the following orders:-

- i. Sanction is accorded for a sum of ₹ 9,94,53,375 (Rupees Nine crore ninety four lakh fifty three thousand three hundred and seventy five only) towards supply of two sets stitched ready made colour uniform @ ₹ 131.25 per set to 3,78,870 Pre School Education children in the Anganwadi centres in the districts of Chennai, Vellore, Trichy, Theni, Dindigul, Villupuram, Ariyalur, Perambalur, Nagapattinam and Tirunelveli for the year 2018-2019.
- ii. The Director cum Mission Director is permitted to authorise the District Project Officers / Child Development Project Officers concerned to procure and supply the stitched ready made colour uniform dresses as per the beneficiaries allotted to their Districts following Tamilnadu Transparency in Tenders Act, 1998 and Rules, 2000.
- iii. The Director cum Mission Director is permitted to authorise the District Project Officers / Child Development Project Officers concerned to draw and disburse the amount as per their requirement to procure the stitched ready made Colour Uniforms dresses.
- iv. The Director cum Mission Director is permitted to make inter- district transfer of Colour uniforms dresses / funds based on the actual requirement (no. of beneficiaries), if required, as the beneficiaries may vary, within overall financial allocation.
- v. The Director cum Mission Director, Integrated Child Development Services Scheme shall send necessary utilisation certificate to Government within time.

5. The expenditure sanctioned in para 4(i) above shall be debitible under the Head of Account:-

2236-Nutrition-02 Distribution of Nutritious food and Beverages -101 Special Nutrition programmes – States Expenditure - JN –Tamil Nadu Integrated Child Development Services Scheme - Phase III - 46 – Clothing, Tentage and Stores. (DP code 2236 02 101 JN 4605).

6. Necessary additional funds of ₹ 58,92,375 will be provided in RE/FMA 2018-2019. Pending provision of such funds, the Director cum Mission Director, Integrated Child Development Services Scheme is authorized to draw and disburse the amount sanctioned in paragraph 4(i) above. However this expenditure shall be brought to the notice of Legislature by specific inclusion in the Supplementary Estimates 2018-2019. The Director cum Mission Director, Integrated Child Development Services Scheme shall include this expenditure while sending the proposal to the Government in Finance (SW) Department, for inclusion in RE/FMA 2018-2019 without fail. The Director cum Mission Director, Integrated Child Development Services Scheme shall also send necessary draft explanatory notes to Finance (SW/BG-I) Department for inclusion in the Supplementary Estimates 2018-2019 at the appropriate time without fail.

7. This order issues with the concurrence of Finance (SW) Department vide its U.O.No.29338/Fin(SW)/2018, Dated 21.06.2018 and Additional Sanction Ledger No.438 (Four hundred and thirty eight).
